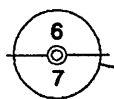

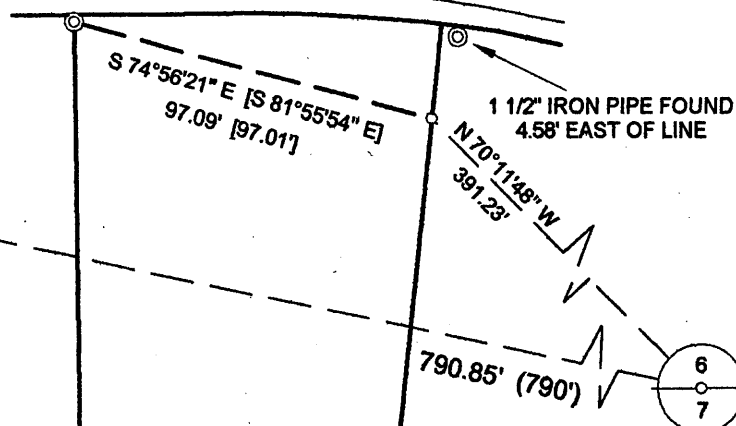

1 1/2" IRON PIPE FOUND IN PLACE



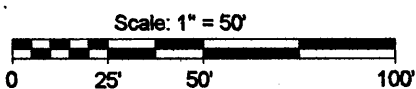

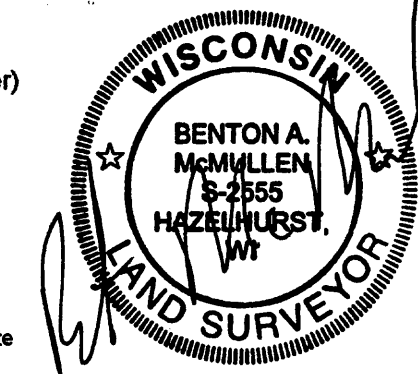
