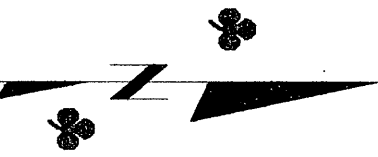


Lot -15-, Block 6 of the Plat of Flambeau Heights

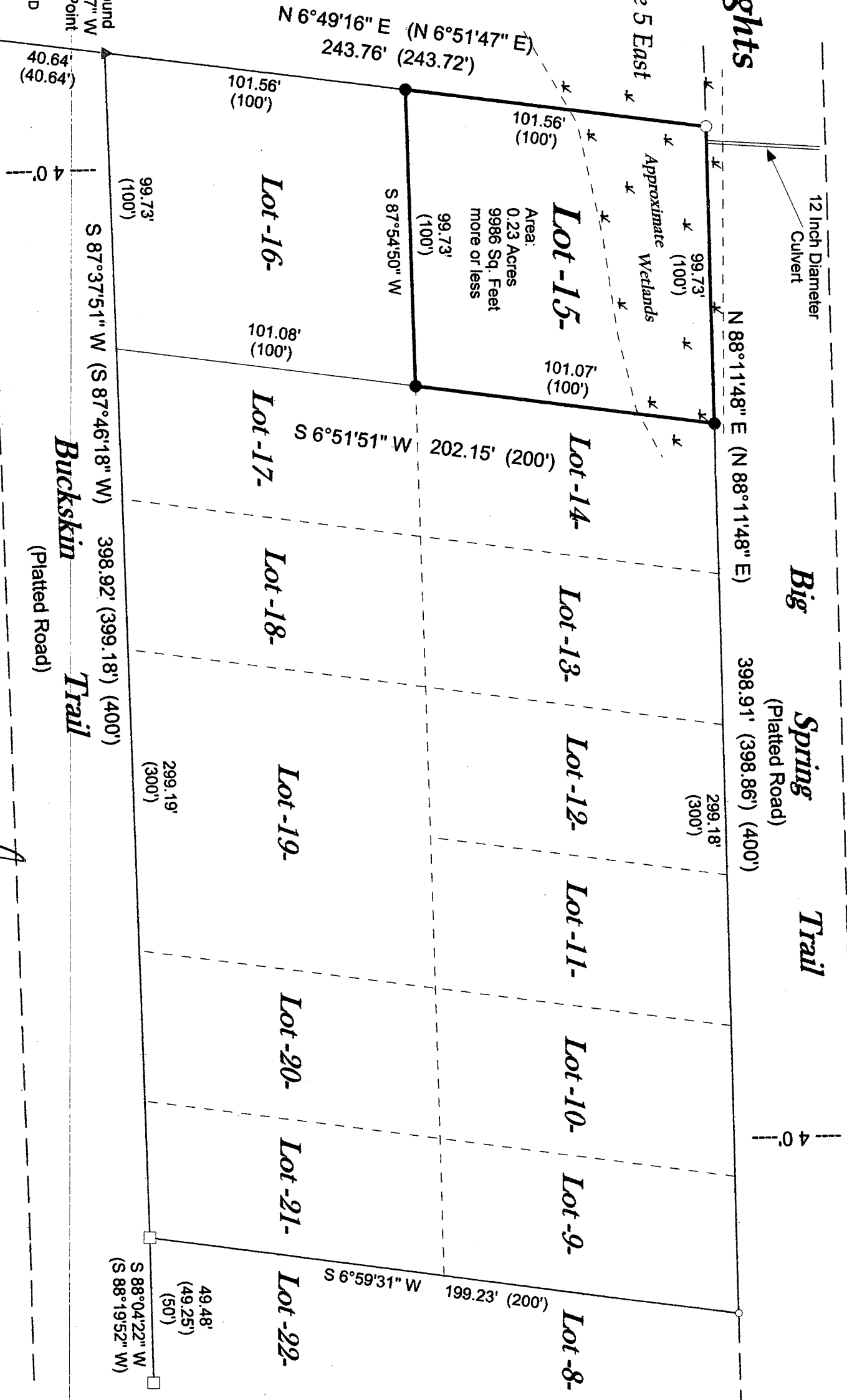
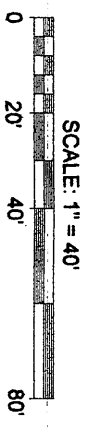

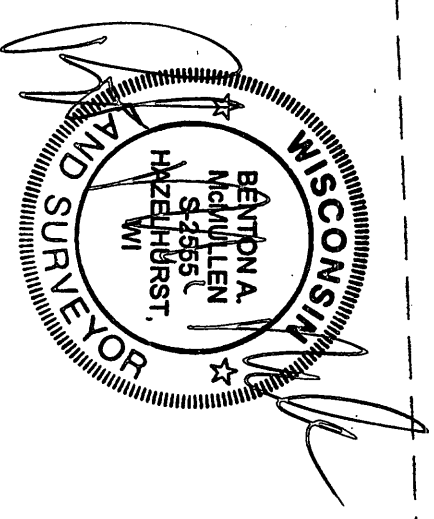
