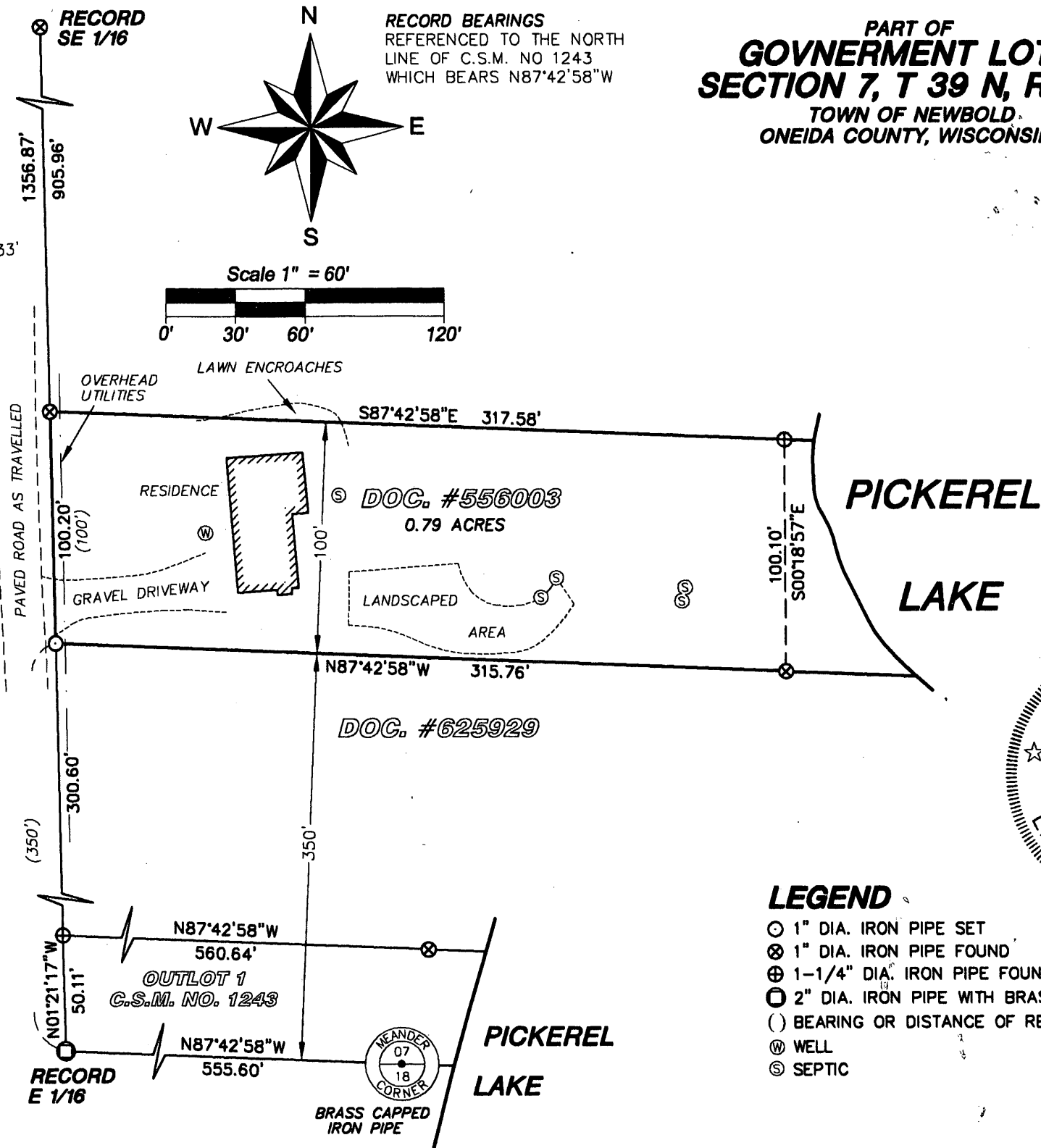

**DESCRIPTION**

A parcel of land in part of Government Lot 4, Section 7, Township 39 North, Range 8 East, Town of Newbold, Oneida County, Wisconsin, more particularly described as follows: Commencing at the Meander Corner common to Sections 7 & 18, marked by a brass capped iron pipe on the westerly shoreline of Pickerel Lake; thence along the section line North 87°42'58" West for a distance of 555.60 feet to the southwest corner of said Government Lot 4 corner, marked by a brass capped iron pipe; thence along the west line of said Government Lot 4 North 01°21'17" West for a distance of 350.71 feet to an iron pipe, the PLACE OF BEGINNING. Thence continuing North 01°21'17" West for a distance of 100.20 feet to an iron pipe; thence South 87°42'58" East for a distance of 317.58 feet to an iron pipe near the westerly shoreline of said Pickerel Lake; thence along said shoreline South 00°18'57" East for a distance of 100.10 feet to an iron pipe; thence North 87°42'58" West for a distance of 315.76 feet to the PLACE OF BEGINNING. The side lot lines extend to the shoreline of Pickerel lake including the lands lying between said shoreline and the meander-line.
