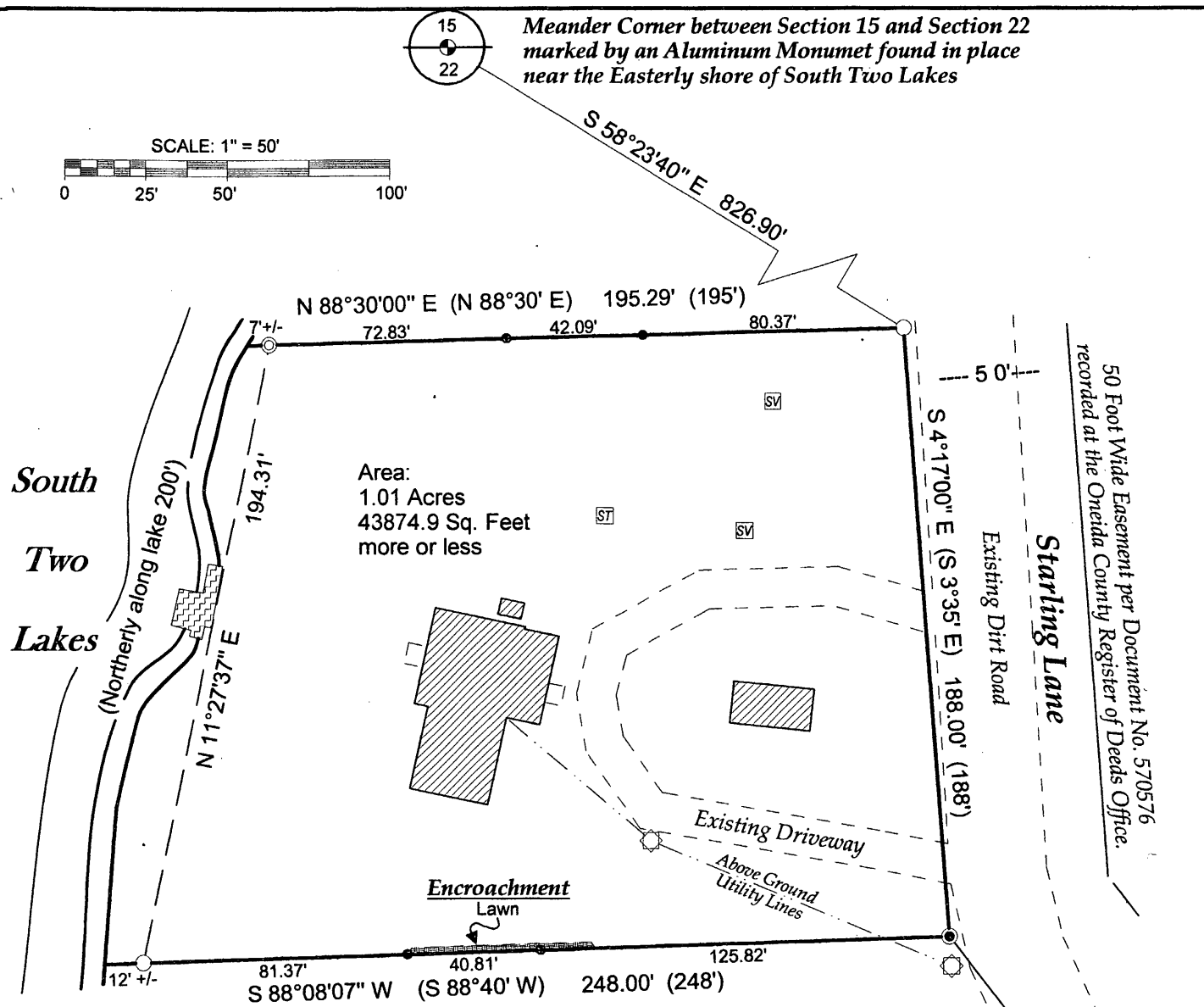
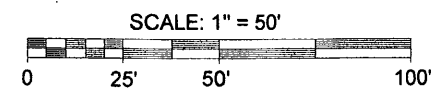

Description

Part of Government Lot 2, Section 22, Township 38 North, Range 7 East, town of Lake Tomahawk, Oneida County, Wisconsin shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 12th Day of November, 2009 with a Job No. of 209073, previously described in Document No. 532673 recorded at the Oneida County Register of Deeds Office and more particularly described as follows:

Commencing at the Meander Corner between Section 15 and Section 22 marked by an Aluminum Monument near the Easterly shore of South Two Lakes; thence South 58° 23' 40" East (Assumed North based on the Northerly line of the parcel described herein which bears North 88° 30' 00" East), a distance of 826.90 feet to a 1 3/4" Iron Pipe on the Westerly right-of-way of a 50 foot wide easement, said point being the POINT OF BEGINNING.

Thence South 4° 17' 00" East along said right-of-way, a distance of 188.00 feet to a 1" Iron Pipe; thence leaving said right-of-way South 88° 08' 07" West, a distance of 248.00 feet to a 1 3/4" Iron Pipe near the Easterly shore of South Two Lakes; thence meandering along said lake shore North 11° 27' 37" East, a distance of 194.31 feet to a 1 1/4" Iron Pipe; thence leaving said lake shore North 88° 30' 00" East, a distance of 195.29 feet to the POINT OF BEGINNING.

Said described tract containing 1.01 acres (43874.9 square feet), more or less.

Subject to any easements, restrictions, or rights of way of record or of use.

Including all those lands lying between the above described meander line and the water's edge of South Two Lakes.
