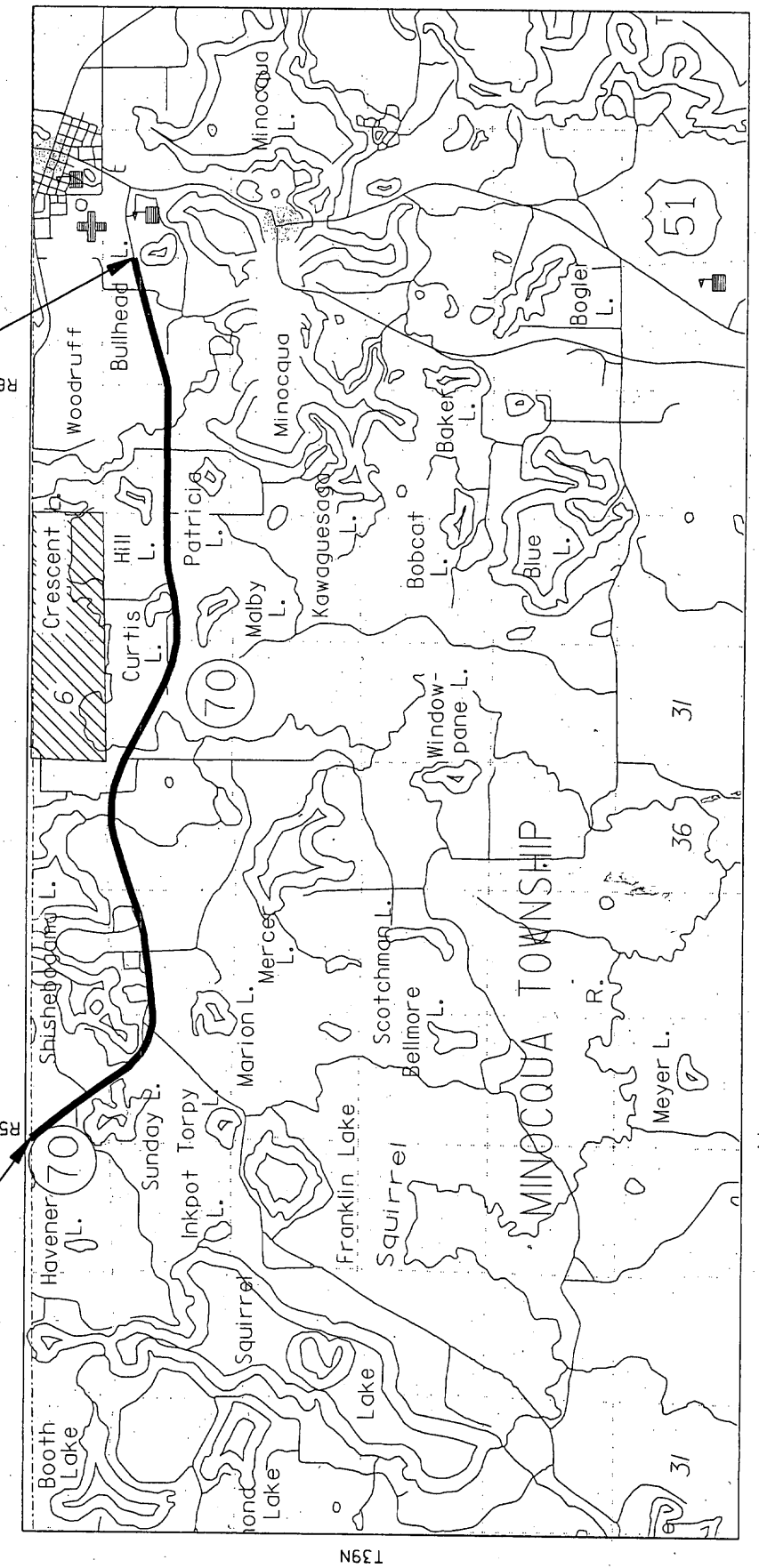

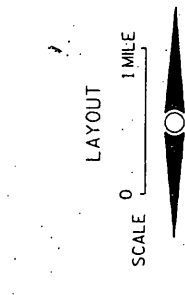

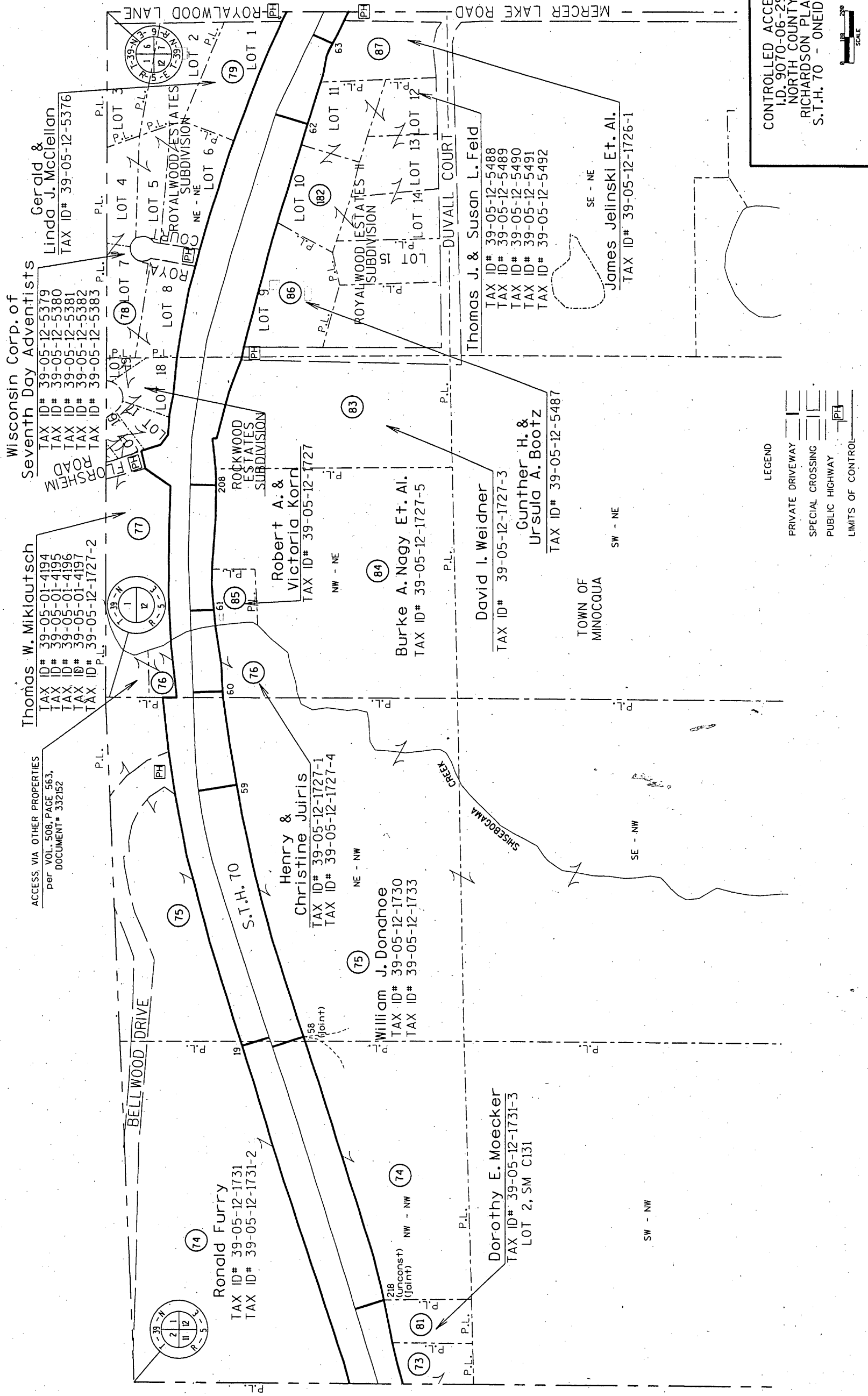


CONTROLLED ACCESS PLAN

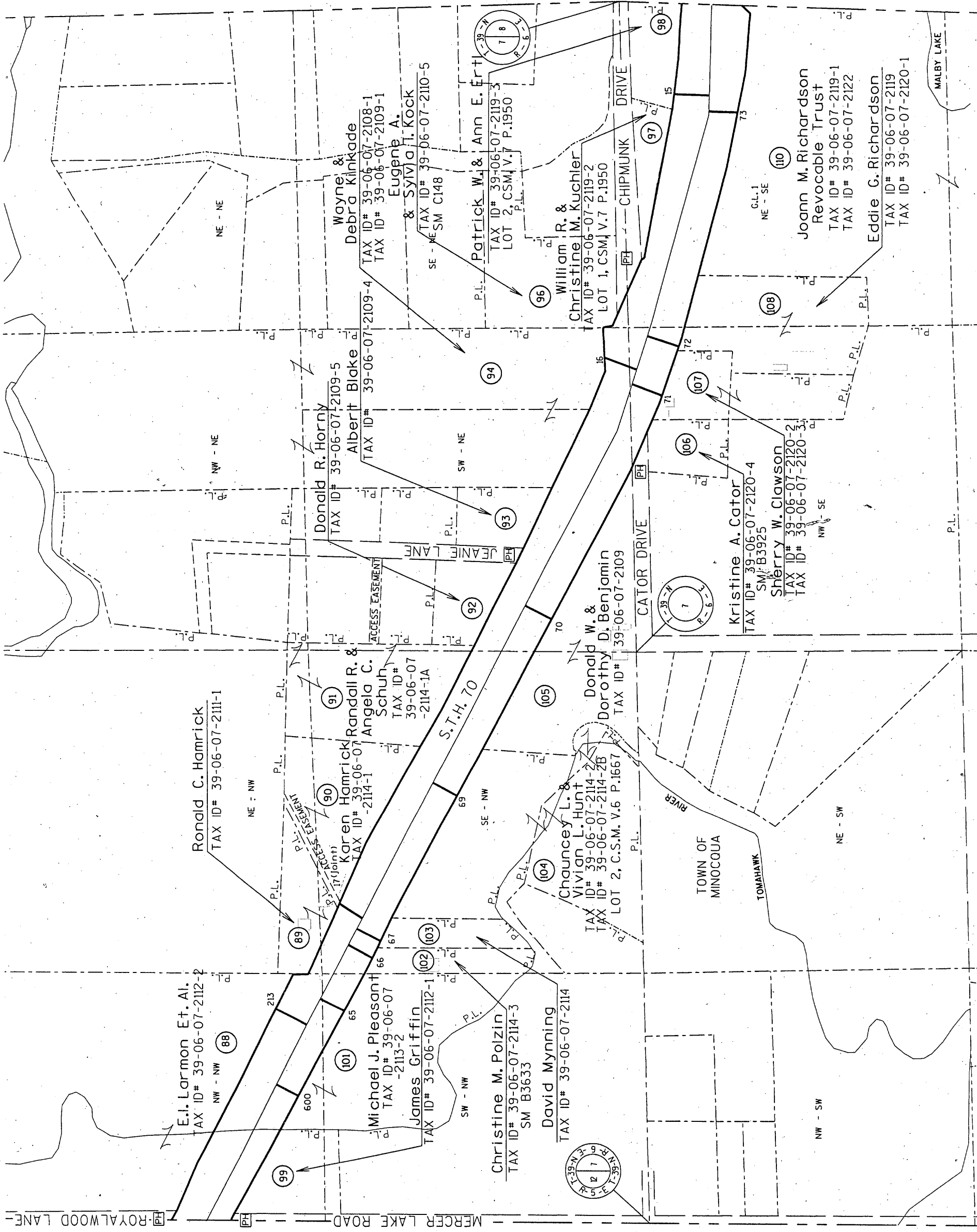

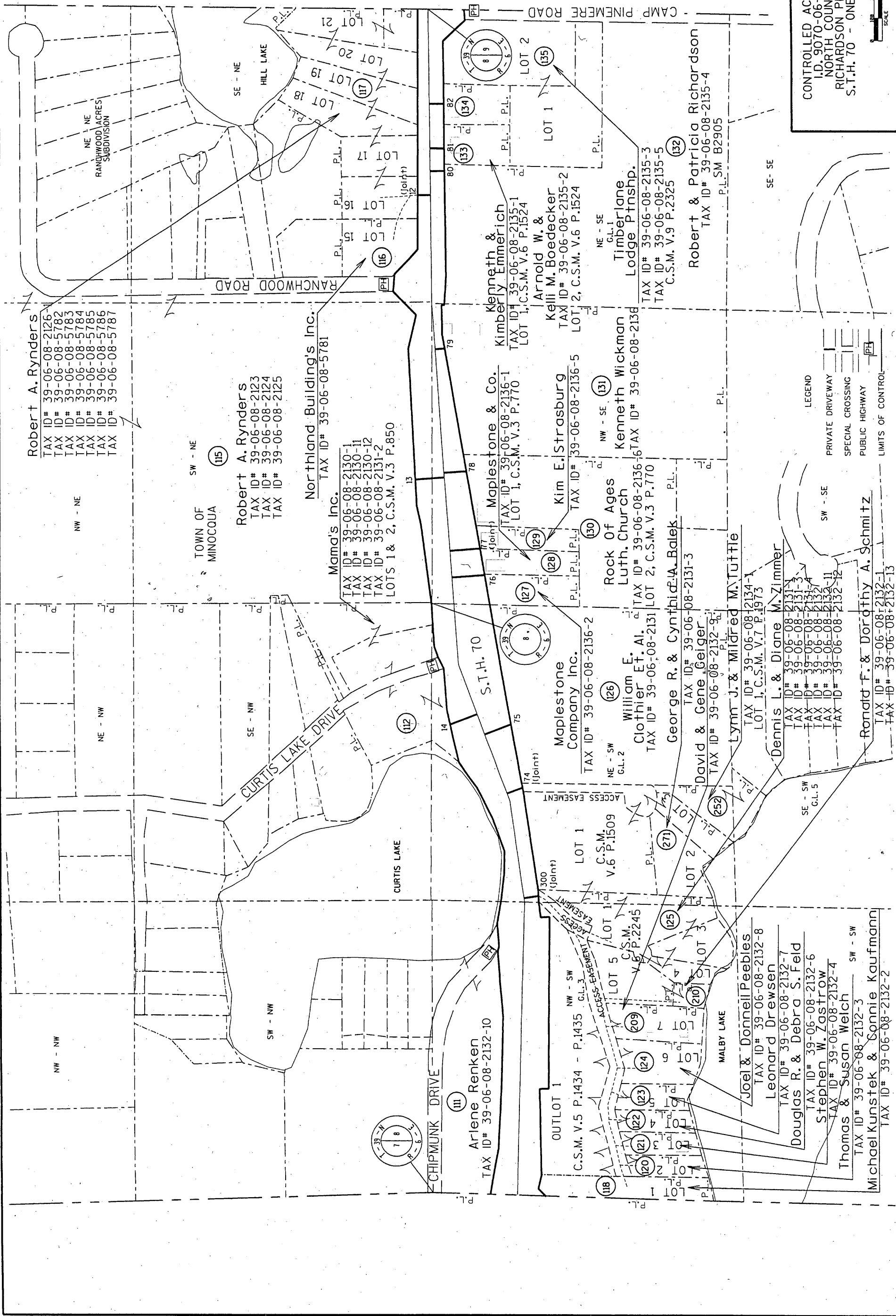

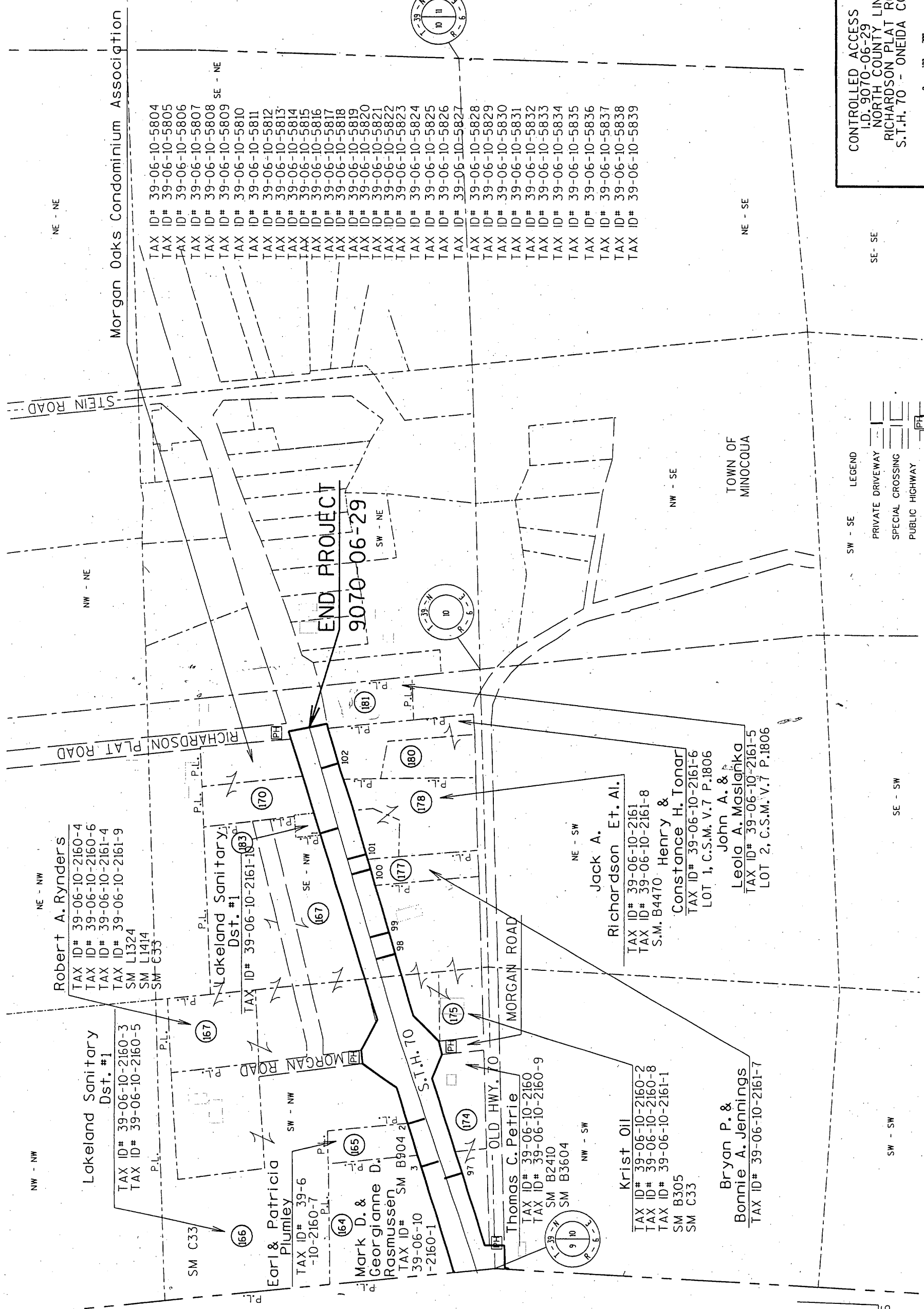
CONTROLLED ACCESS PLAN
