

**PARCEL #1**  
A parcel of land in Government Lot 2 in Section 3, Township 37 North and Range 11 East described as follows:  
Beginning at the Northwest Corner of Gov't Lot 2 said Corner being marked by an Iron Pipe and a Cedar Post; thence S1°16'1/2 along the West line of Gov't Lot 2 a distance of 249.5 feet to a Cedar Post; thence N86°12'2 a distance of 184.5 feet to the Center line of a Road; thence N3°21'1/2 along said center line a distance of 230.0 feet to the North line of Gov't Lot 2 said point marked by a Cedar Post; thence West along the North line of Gov't Lot 2 a distance of 215.0 feet to the place of beginning. Subject to all easements, restrictions and reservations of record.

**PARCEL #2**  
A parcel of land in Government Lot 2 in Section 3, Township 37 North and Range 11 East described as follows:  
Commencing at the Northwest Corner of Gov't Lot 2; thence S1°16'1/2 along the West line of Gov't Lot 2 a distance of 249.5 feet to a Cedar Post marking the PLACE OF BEGINNING of this description; thence again S1°16'1/2 along the West line of Gov't Lot 2 a distance of 258.9 feet to a Cedar Post; thence N86°04'1/2 a distance of 182.3 feet to the Center line of a Road; thence N3°21'1/2 along said center line a distance of 260.5 feet; thence S86°12'W a distance of 184.5 feet to the place of beginning. Subject to all easements, restrictions and reservations of record.

**PARCEL #3**  
A parcel of land in Government Lot 2 in Section 3, Township 37 North and Range 11 East described as follows:  
Commencing at the Northwest Corner of the Government Lot 2; thence S1°16'1/2 along the West line of Gov't Lot 2 a distance of 508.4 feet to a Cedar Post marking the PLACE OF BEGINNING of this description; thence again S1°16'1/2 along the West line of Gov't Lot 2 a distance of 191.9 feet to a Cedar Post; thence N86°04'1/2 a distance of 121.0 feet to the Center line of a Road; thence N8°35'1/2 along said center line a distance of 195.5 feet; thence S86°04'1/2W a distance of 182.3 feet to the place of beginning. Subject to all easements, restrictions and reservations of record.

**PARCEL #4**  
A parcel of land in Government Lot 2 in Section 3, Township 37 North and Range 11 East described as follows:  
Beginning at the Southwest Corner of Gov't Lot 2 said Corner being marked by a Cedar Post; thence N1°16'W along the West line of Gov't Lot 2 a distance of 629.7 feet to a Cedar Post; thence N86°04'1/2 a distance of 121.0 feet to the center line of a Road; thence South along the Center line of said Road S8°35'1/2W a distance of 120.0 feet, S14°25'1/2 a distance of 360.0 feet, S27°50'W a distance of 100 feet, S13°07'W a distance of 35.0 feet to the south line of Gov't Lot 2; thence S89°30'W along the South line of Gov't Lot 2 a distance of 116.8 feet to the place of beginning. Subject to all easements, restrictions and reservations of record.
