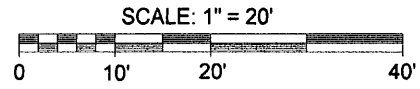

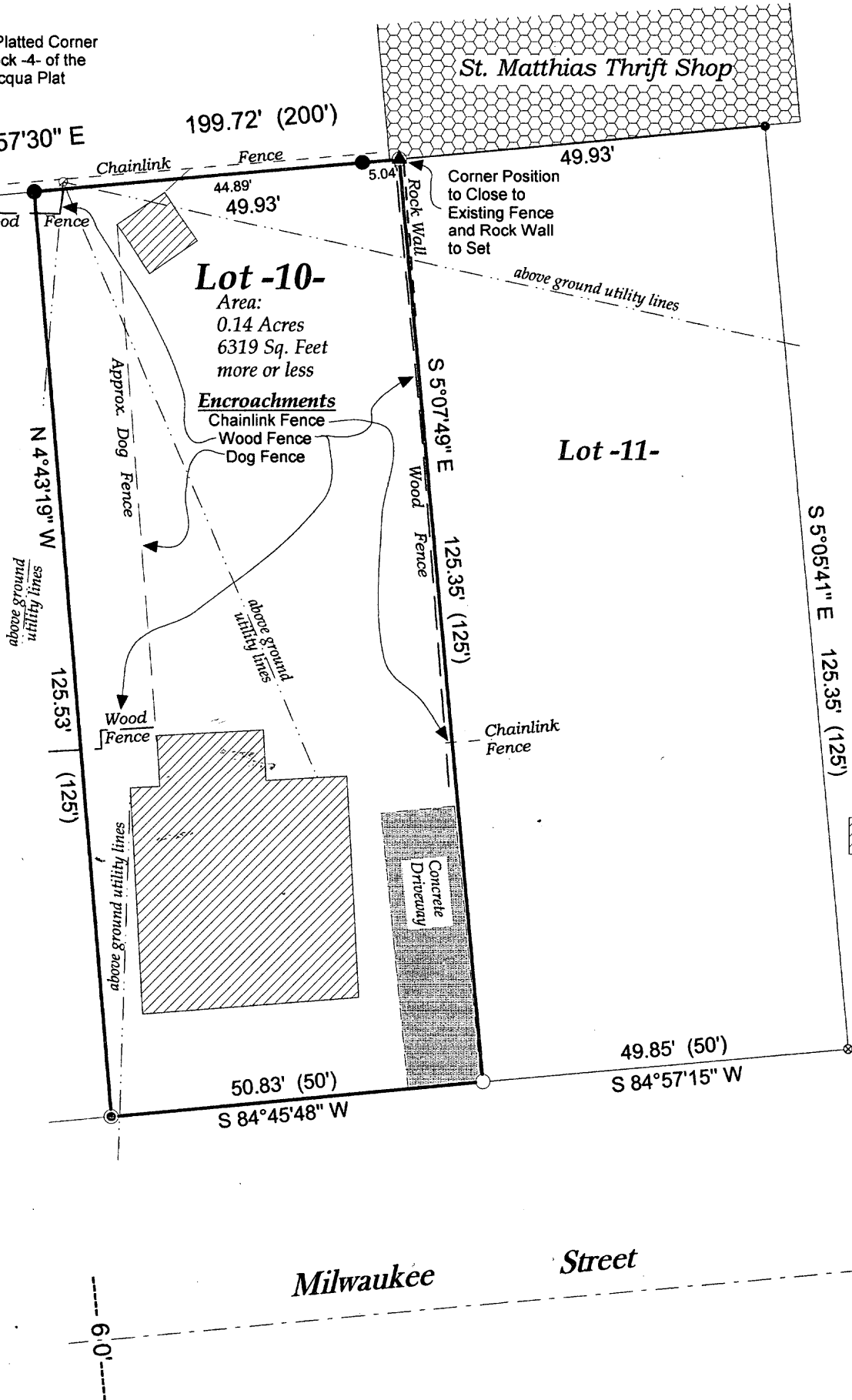
Northwesterly Platted Corner

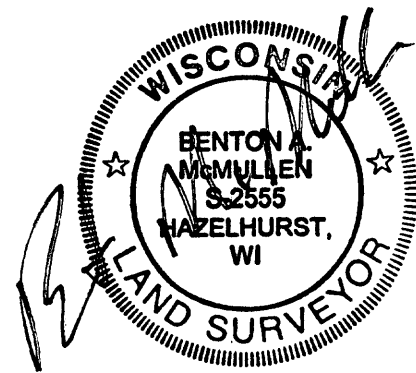
