SURVEYOR'S CERTIFICATE
 I, Robert H. Winat, Registered Land Surveyor, hereby certify: That in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Lynne, and under the direction of MILLARD KAPITZ and VELVA KAPITZ, owners of said land, I have surveyed, divided and mapped WILLOW WOODS, that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed:

Being a parcel of land in the SW 1/4 of the SE 1/4, Section 9, T37N, R4E, Oneida County, Wisconsin, more particularly described as follows:

Beginning at the section corner common to Sections 9, 10, 15 and 16, marked by a W.O.P. brass-capped iron pipe; thence N29°-15.7'W, 64.21 feet to an iron pipe on the easterly right-of-way line of Willow Road; thence along the easterly right-of-way line of Willow Road, along the arc of a curve concave southwesterly, having a radius of 563.19 feet, whose chord bears N26°-27.2'W, 265.04 feet to an iron pipe; thence continuing along the easterly right-of-way line of Willow Road, N40°-27.3'W, 275.36 feet to an iron pipe; thence continuing along the easterly right-of-way line of Willow Road, along the arc of a curve concave easterly, having a radius of 245.2 feet, whose chord bears N14°-33.9'W, 214.20 feet to an iron pipe; thence continuing along the easterly right-of-way line of Willow Road, N11°-20.6'W, 660.10 feet to an iron pipe; thence S27°-11.0'E, 299.73 feet to the northeast corner of the SW 1/4 of the SE 1/4, marked by an iron pipe, with and by a 5" brass bearing 348°W, 27.7 feet and by a 4" White Pine bearing 54°E, 7.1 feet; thence S0°-34.0'W, 1314.72 feet along the east line of Section 9 to the place of beginning.
