SURVEYOR'S CERTIFICATE AND WAIVER

- () Tie to a Public Land Survey System Corner (A-E 7.04).

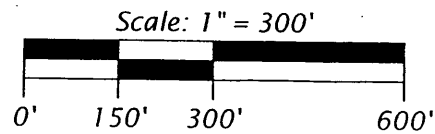

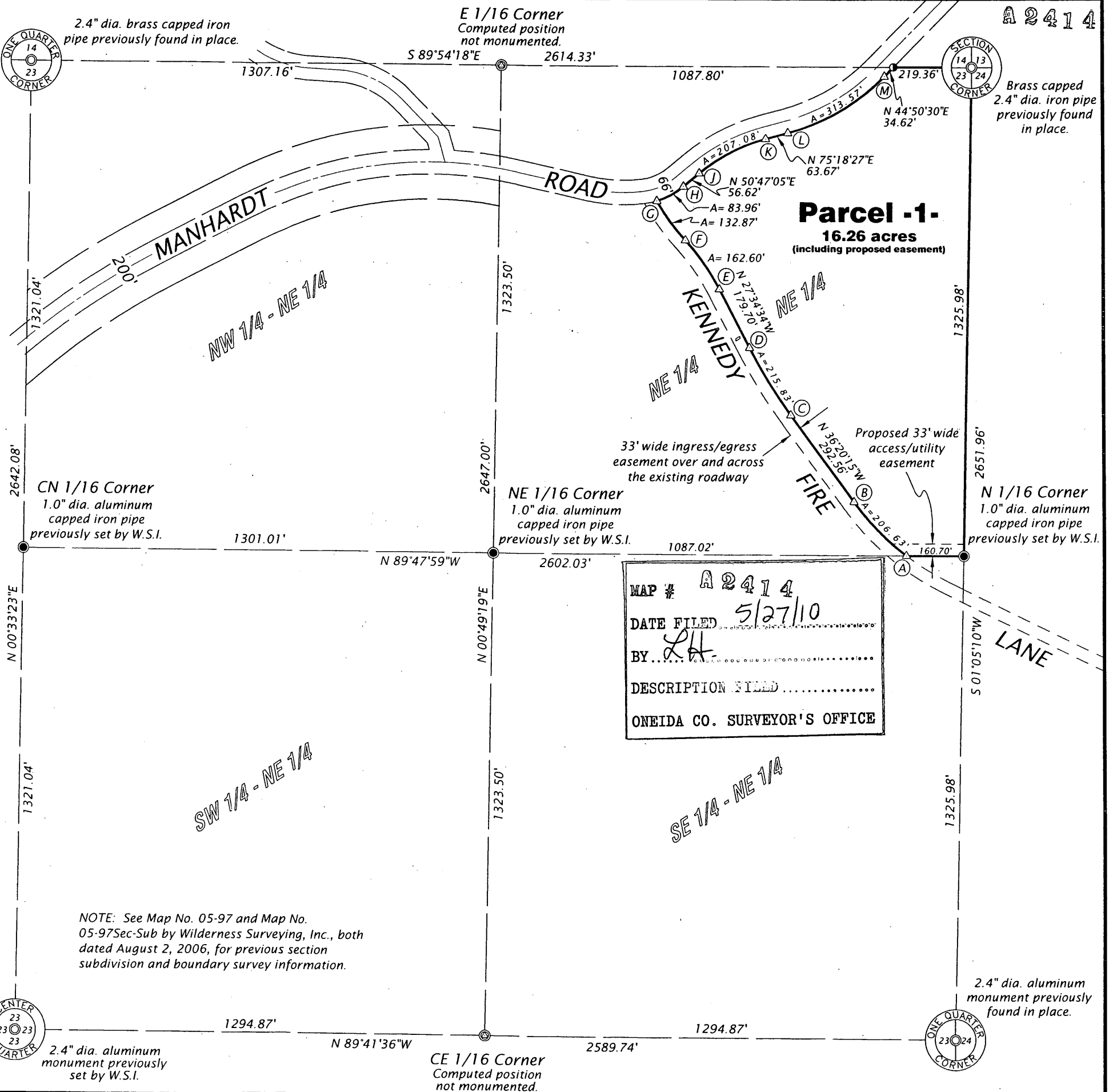
