## LEGAL DESCRIPTION:

Lands being the NW.1/4 of the SE.1/4 and part of Government Lot 3, all in Section 34, T.39 N., R.11 E., Town of Three Lakes, Oneida County, Wisconsin and being more particularly described as follows:

Commencing at the East ½ corner of said Section 34; thence S.89°06'19"W., along the North line of the NE.1/4 of the SE.1/4, a distance of 1407.86 feet to a 1"diameter iron pipe at the Northeast corner of said NW.1/4 of the SE.1/4 and being the point of beginning of parcel to be described; thence S.1°57'28"E., a distance of 1026.69 feet to a 1" diameter iron pipe found at the Southeast corner of said NW.1/4 of the SE.1/4; thence S.86°07'52"W., a distance of 1416.79 feet to a 1" diameter iron pipe found at the Southwest corner of said NW.1/4 of the SE.1/4 and being the Southeast corner of said Government Lot 3; thence S.84°27'36"W., along the South line of said Government Lot 3, a distance of 60.00 feet to a 3/4" diameter iron road set on the West right-ofway line of Leatzow Road and being the Southwest corner of parcel described in Document No. 656508 in the Register of Deeds Office; thence N. 5°57'33"W., along the West line of said Document No. 656508, a distance of 894.52 feet to a meander corner being a 1 1/2 " diameter iron pipe found on the South shore of Big Fork Lake; thence S.63°26'44"E., along a meander line a distance of 120.73 feet to a meander corner being a 1 1/2" diameter iron pipe found on the East line of said Government Lot 3 and being the West line of said NW.1/4 of the SE.1/4; thence N.3°04'34"W., continuing along said West line of the NW.1/4 of the SE.1/4, a distance of 270.44 feet to the Northwest corner of said NW.1/4 of the SE.1/4; thence N.89°08'05"E., along the North line of said NW.1/4 of the SE.1/4, a distance of 1437.77 feet to the point of beginning. Said parcel includes that area of Government Lot 3, lying between said meander line and the normal high water line of said Big Fork Lake and the lateral extension of the above described lands.

The above described lands being 1,589,334 square feet or 36.48 acres, more or less.

The above described being subject to a right-of-way for road purposes to the Town of Three Lakes as recorded in Volume 146 of Deeds on pages 144 and 145 in said Register of Deeds Office.

That portion of said NW.1/4 of the SE.1/4 lying in the lakebed of said Big Fork Lake being subject to the benefit of the public. Said area of lake bed being 219,900 square feet or 5.05acres, more or less.
