DESCRIPTION

A PARCEL OF LAND IN GOVERNMENT LOT 1, SECTION 3, TOWN 35 NORTH, RANGE 5 EAST, TOWN OF LITTLE RICE, ONEIDA COUNTY, WISCONSIN, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER OF SAID SECTION 3, THENCE ALONG THE WEST LINE OF SAID SECTION 3, S 03°06'42' W, 2312.62 FEET TO THE NORTH 1/16 CORNER ON THE WEST LINE OF SAID SECTION 3, MARKED BY A FOUND 3/4 INCH IRON ROD TOPPED WITH A 3 INCH YELLOW, PLASTIC CAP; THENCE CONTINUING ALONG SAID WEST LINE OF SAID SECTION 3, S 03°06'42" W, 514.13 FEET; THENCE LEAVING SAID WEST LINE OF SAID SECTION 3, S 75°18'23" E, 17.39' TO A FOUND 1 1/2 INCH IRON PIPE ON THE EASTERLY RIGHT OF WAY OF NORTH LAKE ROAD AND THE POINT OF BEGINNING:

THENCE ALONG SAID EASTERLY RIGHT OF WAY OF NORTH LAKE ROAD S 11'41'41' W, 90.05 FEET TO A FOUND ANGLE IRON; THENCE LEAVING SAID RIGHT OF WAY S 70'38'58" E, 77.46 FEET TO A SET 3/4 INCH BY 30 INCH IRON ROD ON THE WESTERLY SHORE OF BURROWS LAKE AND THE BEGINNING OF A MEANDER LINE ALONG SAID WESTERLY SHORE; THENCE ALONG SAID MEANDER LINE N 33'04'16" E, 101.39 FEET TO A FOUND 1 1/2 INCH IRON PIPE, BEING THE TERMINATION OF SAID MEANDER LINE; THENCE LEAVING SAID MEANDER LINE N 75'18'23" W, 113.88 FEET TO A FOUND 1 1/2 INCH IRON PIPE ON THE EASTERLY RIGHT OF WAY OF NORTH LAKE ROAD AND THE POINT OF BEGINNING.

SAID PARCEL CONTAINS ALL LANDS BETWEEN THE MEANDER LINE AND THE WATER'S EDGE OF BURROWS LAKE.

SAID PARCEL SUBJECT TO ALL EASEMENTS, RESTRICTIONS, RESERVATIONS, COVENANTS AND RIGHTS OF WAY, RECORDED OR UNRECORDED.

SAID PARCEL CONTAINS 9455 SQ. FT \pm OR 0.2 ACRES, \pm TO WATER'S EDGE. SAID PARCEL CONTAINS 8935 SQ. FT. \pm OR 0.2 ACRES, \pm TO MEANDER LINE.
