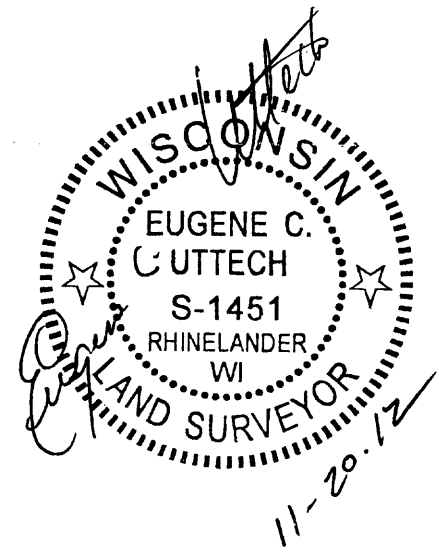
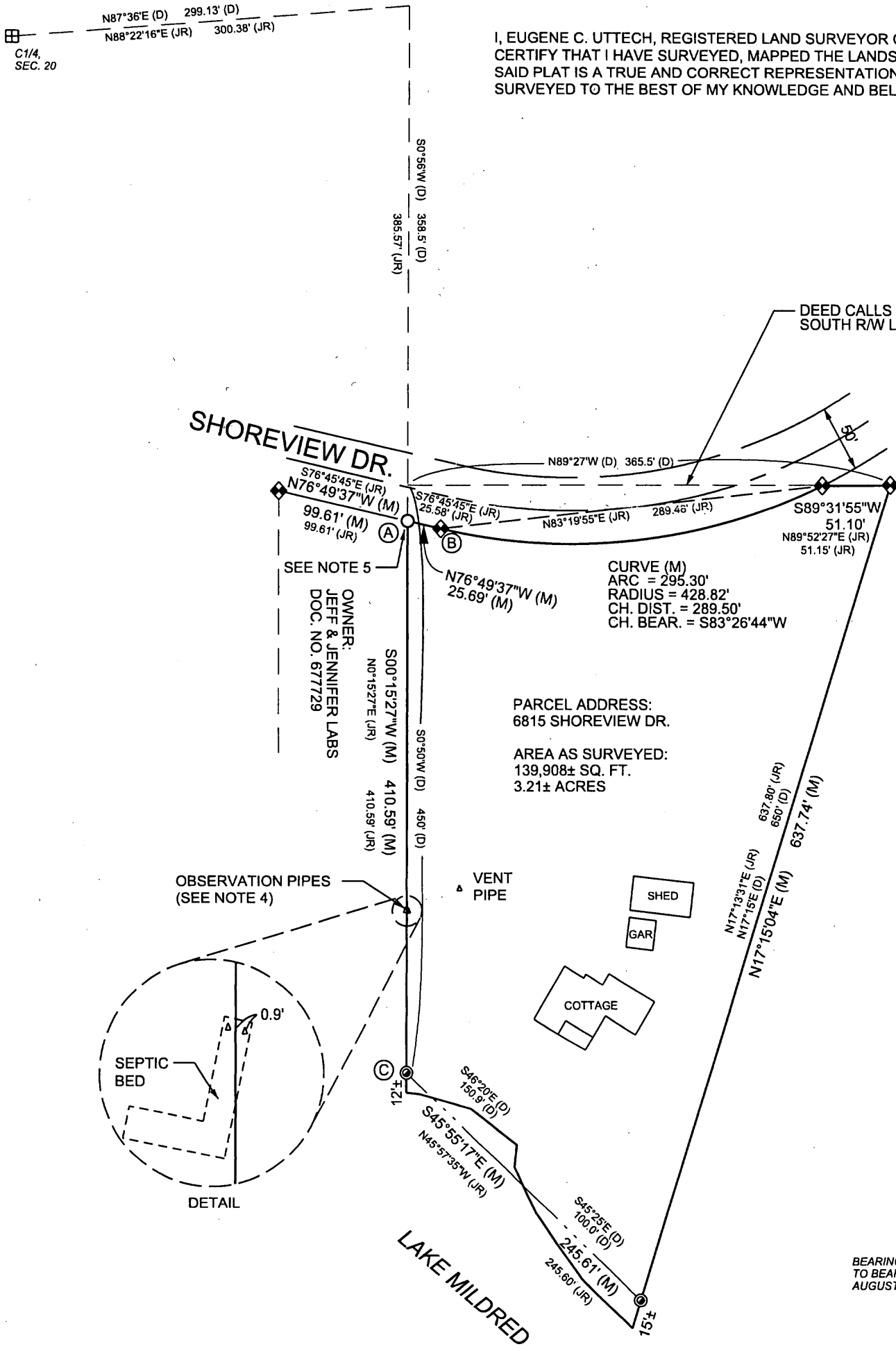

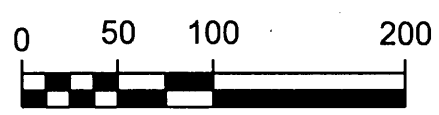
SURVEYOR NOTES:

1. THIS MAP DRAFTED TO SHOW DISCREPANCIES BETWEEN PRESENT DEED AND IRON PIPES FOUND.
2. THE PRESENT DEED TO OWNERS, V. 972 PG. 264 IS SAME AS SURVEY MAP PREPARED BY ROWINSKI ENGINEERING CO. DATED 8/26/1959 AND FILED IN THE COUNTY SURVEYORS OFFICE, MAP L945.
3. ON AUGUST 28, 1992 THIS LOT WAS SURVEYED BY JEAN F. RESVICK, RLS S-802 FOR THE OWNER, ROBERT SOMMERFELDT AND FILED IN THE COUNTY SURVEYORS OFFICE, MAP B2538. THE IRON PIPES FOUND AGREE WITH PLAT OF SURVEY BY JEAN RESVICK.
4. WHEN THE SANITARY SEWER WAS INSTALLED ON ADJACENT PROPERTY, IT APPEAR THE PROPERTY LINE WAS ASSUMED TO BE FROM PIPE "B" TO PIPE "C" ON THIS MAP. THE TRUE PROPERTY LINE IS FROM PIPE "A" TO PIPE "C" ON THIS MAP.
5. THIS LOT CORNER FALLS IN AN AREA THAT HAS BEEN EXCAVATED. I RESET PIPE "A" BY RETRACTING SURVEY BY JEAN RESVICK.
