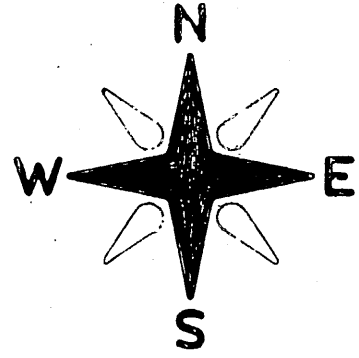
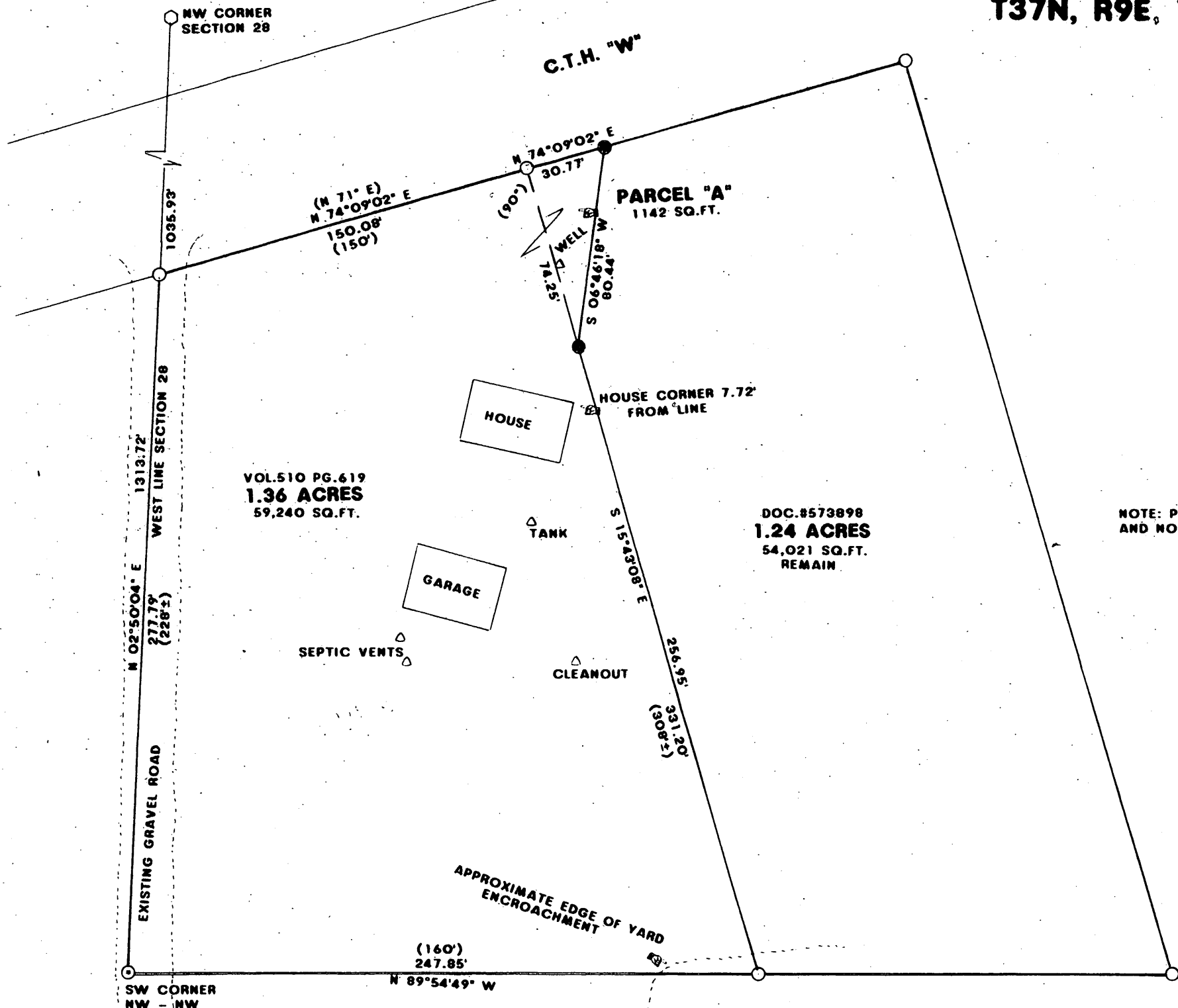

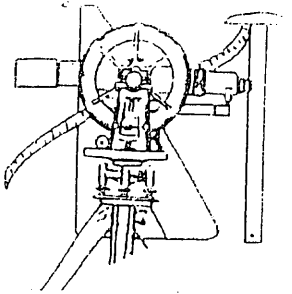

A parcel of land located in part of the NW1/4 of the NW1/4, Section 28, T37N, R9E, Town of Pine Lake, Oneida County, Wisconsin more particularly described as follows:

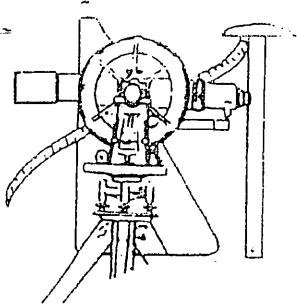
Commencing at an Oneida County Monument marking the Northwest corner of said Section 28, thence S 02°50'04" W a distance of 1035.93' to an iron pipe on the southerly right of way line of C.T.H. "W", thence along said right of way line N 74°09'02" E a distance of 150.08' to an iron pipe and point of beginning, thence continuing along said right of way line N 74°09'02" E a distance of 30.77' to an iron pipe on said right of way line, thence leaving said right of way line S 06°46'18" W a distance of 80.44' to an iron pipe, thence N 15°43'08" W a distance of 74.25' to the point of beginning.

Parcel contains 1,142 sq.ft.

A parcel of land located in part of the NW1/4 of the NW1/4, Section 28, T37N, R9E, Town of Pine Lake, Oneida County, Wisconsin more particularly described as follows:

Commencing at the northwest corner of said Section 28 marked by an Oneida County Capped Aluminum Monument, thence S 02°50'04" W a distance of 1035.93' to an iron pipe on the southerly right of way line of County Trunk Highway "W" and near the center of a gravel road known as Short Road and also the point of beginning, thence along the southerly right of way line of County Trunk Highway "W" N 74°09'02" E a distance of 150.08' to an iron pipe, thence continuing along said right of way line N 74°09'02" E a distance of 30.77' to an iron pipe, thence leaving said right of way line S 06°46'18" W a distance of 80.44' to an iron pipe, thence S 15°43'08" E a distance of 256.95' to an iron pipe, thence N 89°54'49" W a distance of 247.85' to a railroad spike marking the W1/16NW thence along the west line of Section 28 N 02°50'04" E a distance of 277.79' to the point of beginning.
