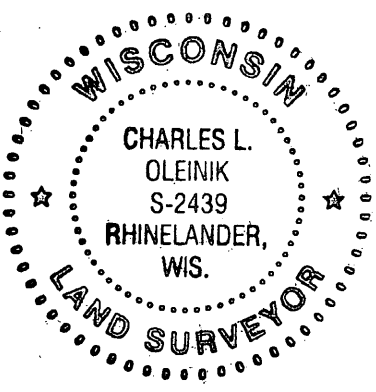
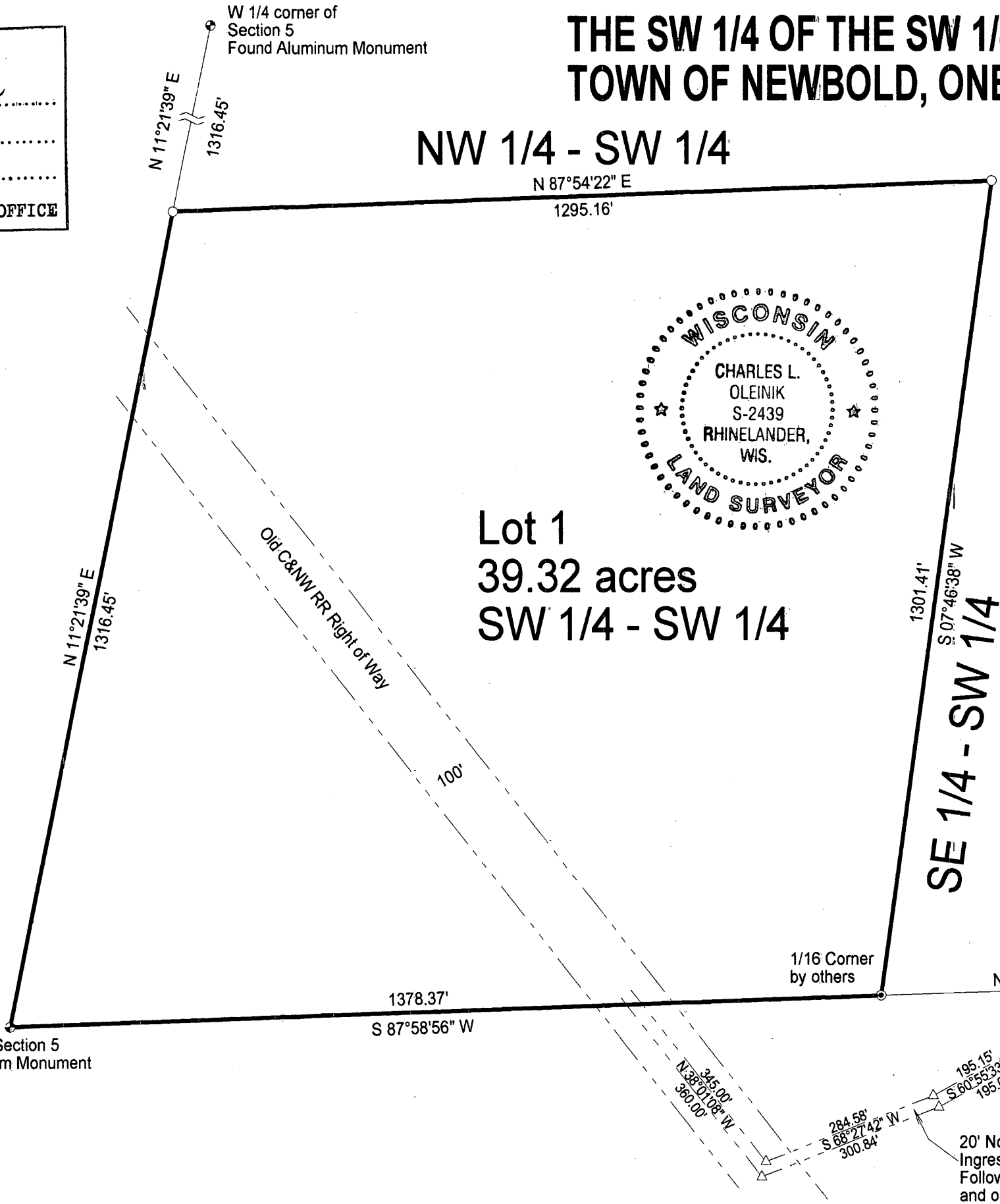

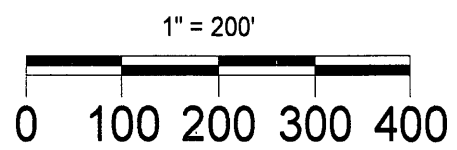

**Lot Description:**  
 The SW 1/4 of the SW 1/4 of Section 5, T37N, R8E, Town of Newbold, Oneida County, Wisconsin, further described as follows: Commencing at the SW corner of said Section 5, marked by a found aluminum monument, also being the POINT OF BEGINNING; thence, along the west line of Section 5, N 11°21'39" E for a distance of 1316.45 feet to the NW corner of the SW 1/4 of the SW 1/4, marked by a 1 1/2" iron pipe, set this survey; thence, along the north line of the SW 1/4 of the SW 1/4, N 87°54'22" E for a distance of 1295.16 feet to the NE corner of the SW 1/4 of the SW 1/4, marked by a 1 1/2" iron pipe, set this survey; thence, along the east line of the SW 1/4 of the SW 1/4, S 07°46'38" W for a distance of 1301.41 feet to the SE corner of the SW 1/4 of the SW 1/4, marked by a found 2" iron pipe; thence, along the south line of the SW 1/4 of the SW 1/4, S 87°58'56" W for a distance of 1378.37 feet to the POINT OF BEGINNING.  
 Said Lot contains approximately 39.32 acres.  
 Along with a 20' wide nonexclusive easement for ingress, egress and utilities, following the existing woods road and the old C&NW RR right of way from Evergreen Ct. to the south line of the SW 1/4 of the SW 1/4.  
 Along with and subject to any other easement, reservation or restriction, apparent or of record.
