Lot 16 and Part of Lot 17 of the Plat of Blue Lake Island being located in Part of Government Lot 6, Section 29, Township 39 North, Range 6 East, town of Minocqua, Oneida County, Wisconsin shown on a survey map by Survey North, LLC of Wisconsin dated the 4th Day of November, 2013 and more particularly described as follows

Commencing at a Meander Corner between Section 29 and Section 28 near the shore of Blue Lake being marked by an Aluminum Monument, thence North 24° 04' 15" West, a distance of 653 22 feet to a 1 9" Iron Pipe on the Westerly right-of-way of Blue Lake Island Road and the Northerly and Easterly right-of-way of Island Point Road, thence leaving said Westerly right-of-way and along said Northerly and Easterly right-of-way North 65° 37' 30" West, a distance of 185 16 feet to a 1 9" Iron Pipe, thence continuing along said right-of-way North 37° 39' 08" West, a distance of 39 37 feet to a 1 9" Iron Pipe, thence continuing along said right-of-way North 15° 31' 22" West, a distance of 139 31 feet to a 1 9" Iron Pipe, thence leaving said right-of-way South 83° 40' 34" West, a distance of 20 66 feet to a 0 7" Iron Pipe on the Westerly right-of-way of Island Point Road, said point being the POINT OF BEGINNING
