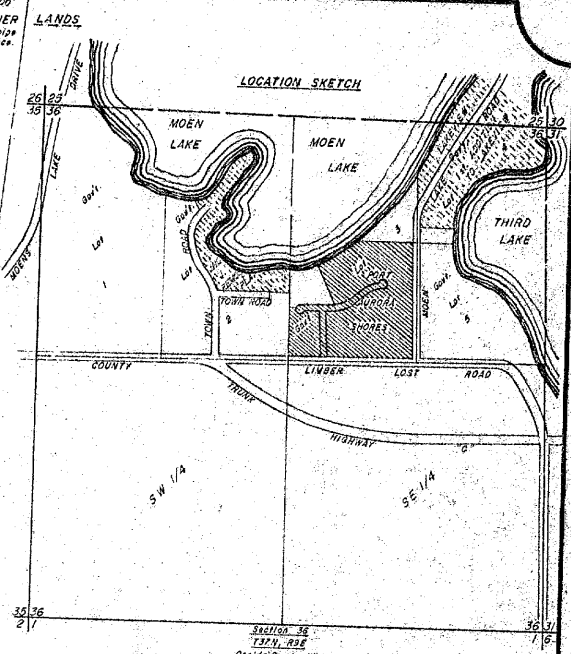
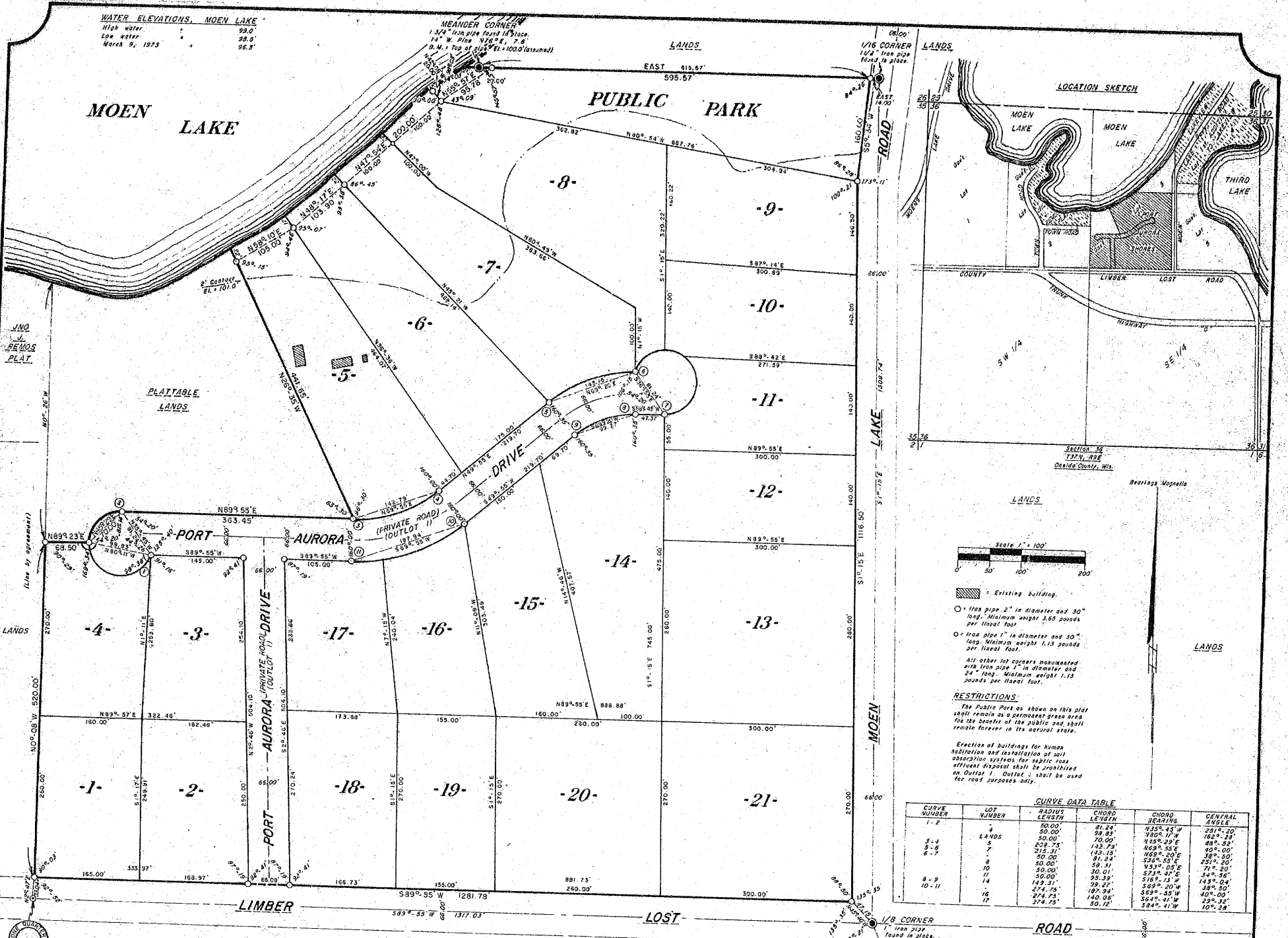

SURVEYOR'S CERTIFICATE

I, JOHN H. FISHER, Registered Land Surveyor, hereby certify: That in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Pine Lake, and under the direction of FRANCIS R. BERENS, owner of said land, I have surveyed, divided and mapped PORT AURORA SHORES, that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed:

Being a parcel of land in Gov't. Lot 3, Section 36, T37N, R9E, Oneida County, Wisconsin more particularly described as follows:

Commencing at the Section Corner common to Sections 36, 31, 1 and 6, marked by an iron pipe; thence N26°-01'W, 3135.43 feet to the one-eighth corner, marked by an iron pipe in the centerline of Limber Lost Road; thence N45°-40'W, 47.15 feet to the place of beginning, marked by an iron pipe at the intersection of the northerly right-of-way line of Limber Lost Road with the westerly right-of-way line of Moen Lake Road.

Including also all lands lying between the meander lines and the shore of Moen Lake.

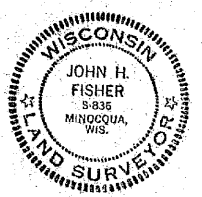
