DESCRIPTION

Part of Government Lot 5, Section 1, Township 37 North, Range 6 East, Town of Cassian, Oneida County, Wisconsin as shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 5th day of June, 2015 with a job number of 215019 and more particularly described as follows:

Commencing at the Northwest section corner of said section marked by a 2" Brass Capped Iron Pipe thence S 57°51'53" E (Magnetic North referenced to the meander line of the parcel described herein which bears S 67°58'52" E) a distance of 386.71' to a 1.900" iron pipe, said point being the POINT OF BEGINNING.

Thence S 87°56'19" E a distance of 169.85' to a 1.900" iron pipe; thence N 68°05'40" E a distance of 64.94' to a 1.900" iron pipe near the shore of Big Bearskin Lake; thence meandering along said lake shore S 67°58'52" E a distance of 106.81' to a 1.900" iron pipe; thence S 34°57'19" W a distance of 99.12' to a 1.900" iron pipe; thence N 75°28'56" W a distance of 271.23' to a 1.900" iron pipe; thence N 15°19'44" W a distance of 36.47' to the POINT OF BEGINNING,

Subject to any easements, restrictions, or rights of way of record or of use.

Including all those lands lying between the above described meander line and the water's edge of Big Bearskin Lake.
