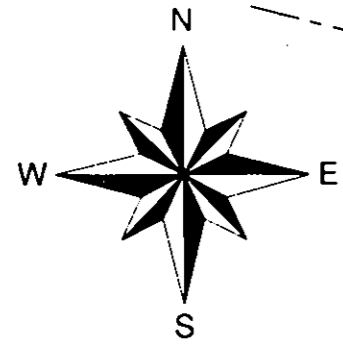
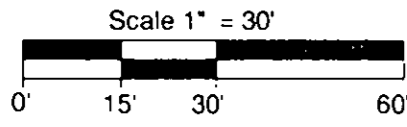

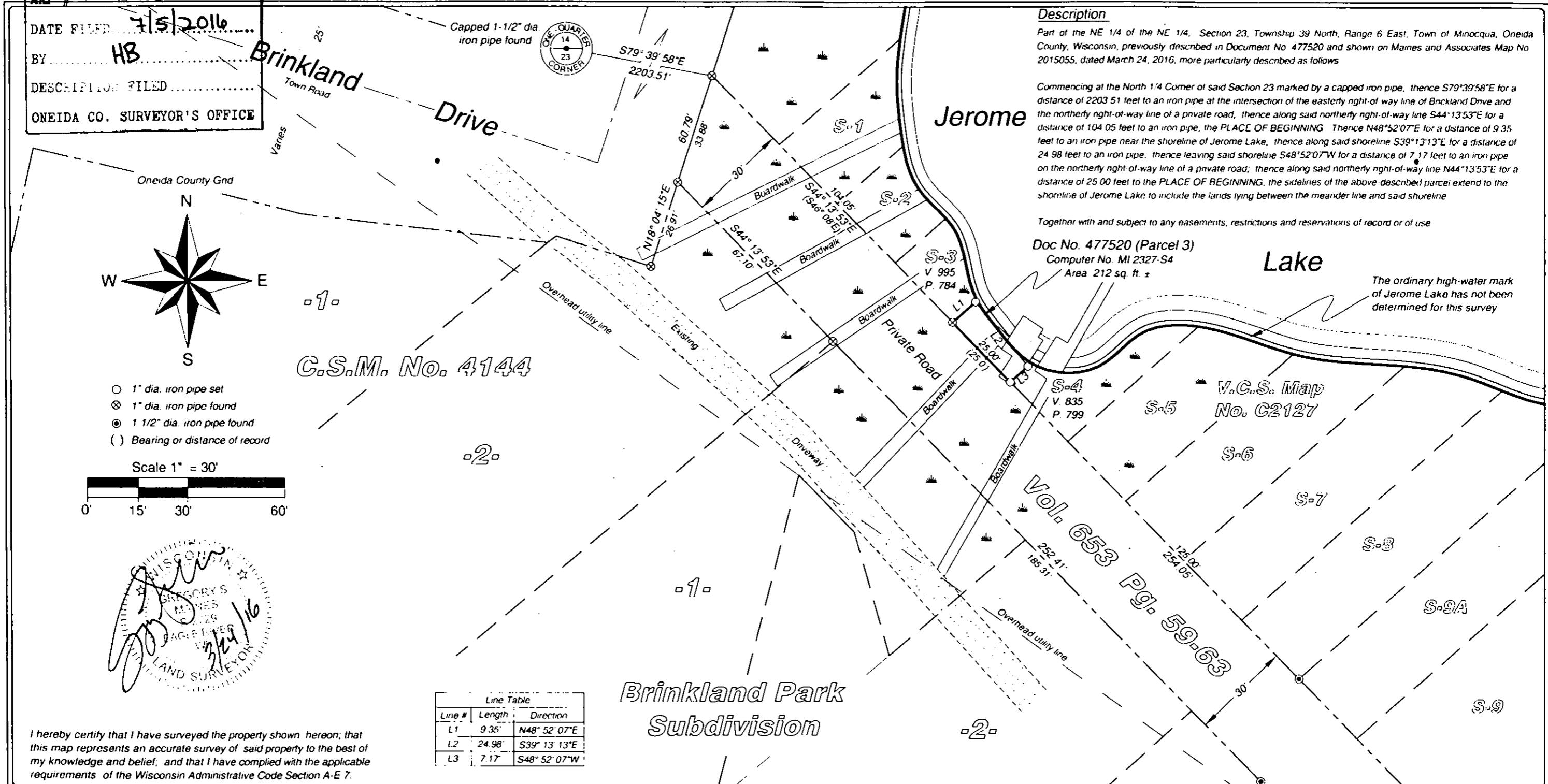
Description
 Part of the NE 1/4 of the NE 1/4, Section 23, Township 39 North, Range 6 East, Town of Minocqua, Oneida County, Wisconsin, previously described in Document No 477520 and shown on Maines and Associates Map No 2015055, dated March 24, 2016, more particularly described as follows

Commencing at the North 1/4 Corner of said Section 23 marked by a capped iron pipe, thence S79°39'58"E for a distance of 2203.51 feet to an iron pipe at the intersection of the easterly right-of-way line of Brinkland Drive and the northerly right-of-way line of a private road, thence along said northerly right-of-way line S44°13'53"E for a distance of 104.05 feet to an iron pipe, the PLACE OF BEGINNING Thence N48°52'07"E for a distance of 9.35 feet to an iron pipe near the shoreline of Jerome Lake, thence along said shoreline S39°13'13"E for a distance of 24.98 feet to an iron pipe, thence leaving said shoreline S48°52'07"W for a distance of 7.17 feet to an iron pipe on the northerly right-of-way line of a private road, thence along said northerly right-of-way line N44°13'53"E for a distance of 25.00 feet to the PLACE OF BEGINNING, the sidelines of the above described parcel extend to the shoreline of Jerome Lake to include the lands lying between the meander line and said shoreline
