

I, LESTER J. SCHMIT, Registered Wisconsin Land Surveyor No. S1192, hereby certify:

That in full compliance with the provisions of Chepter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Nokomis, and under the direction of Adele M.
