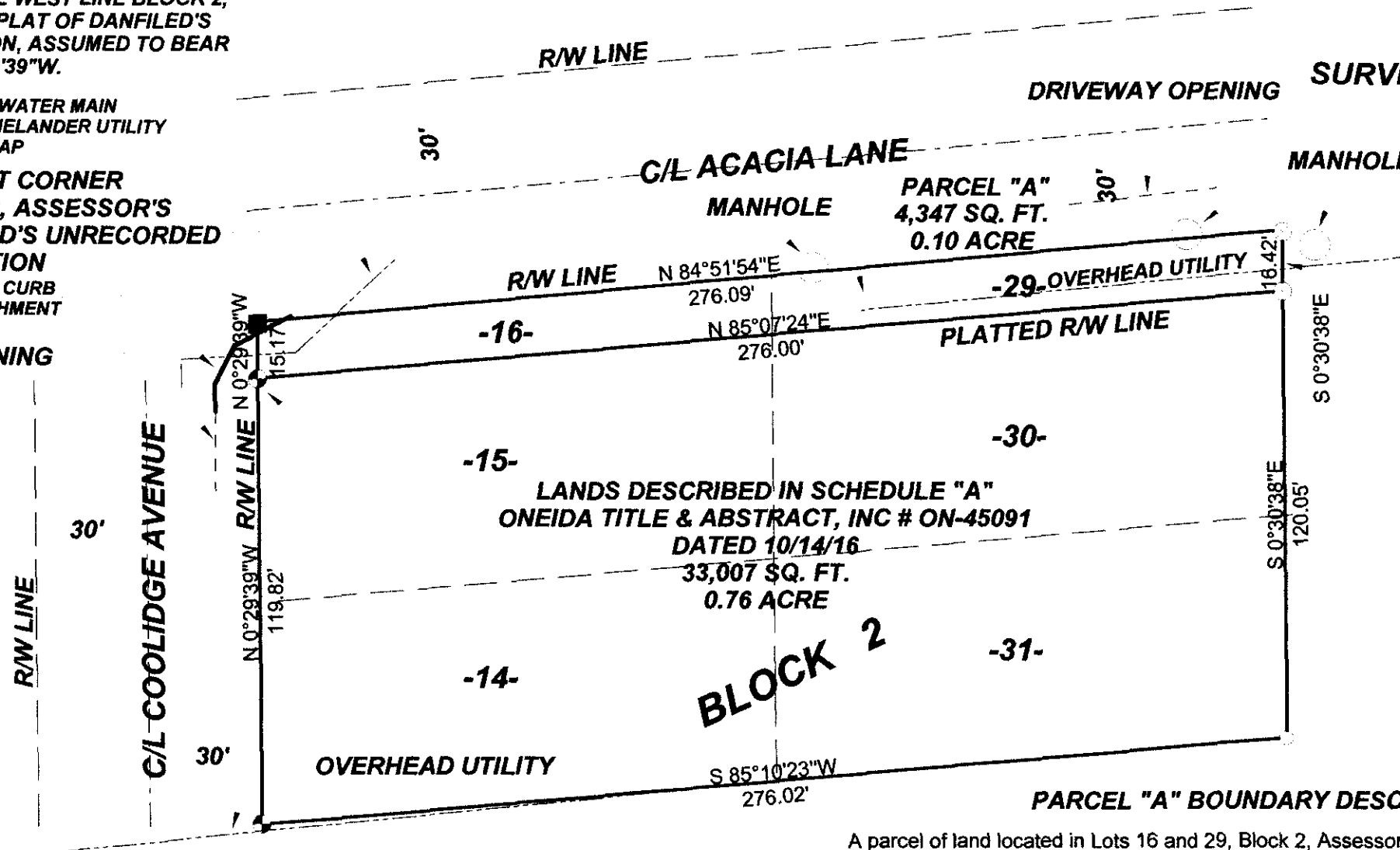

PARCEL "A" BOUNDARY DESCRIPTION

A parcel of land located in Lots 16 and 29, Block 2, Assessor's Replat Of Danfields Unrecorded Addition, All being located in the southeast 1/4 - southwest 1/4, section 32, T37N, R09E, City Of Rhineland, Oneida County, Wisconsin, described as follows:

Commencing at the northwest corner of Lot 15, Block 2, Assessor's Replat Of Danfield's Unrecorded Addition as shown on Bixby Land Surveying Inc drawing number 723 and point of beginning; thence N00°29'39"W, along the east right -of -way line of Coolidge Avenue, 15.17 feet to a point on the south right-of-way line of Acacia Lane; thence along said right-of-way line, N84°51'54"E, a distance of 276.09 feet to an iron pipe; thence leaving said right-of-way line, S00°30'38"E, a distance of 16.42 feet to an iron pipe; thence S85°07'24"W, a distance of 276.00 feet to the point of beginning. Said parcel contains 4,347 square feet or 0.10 acre. Subject to and including easements, restrictions, reservations and right-of-ways of record or in use.
