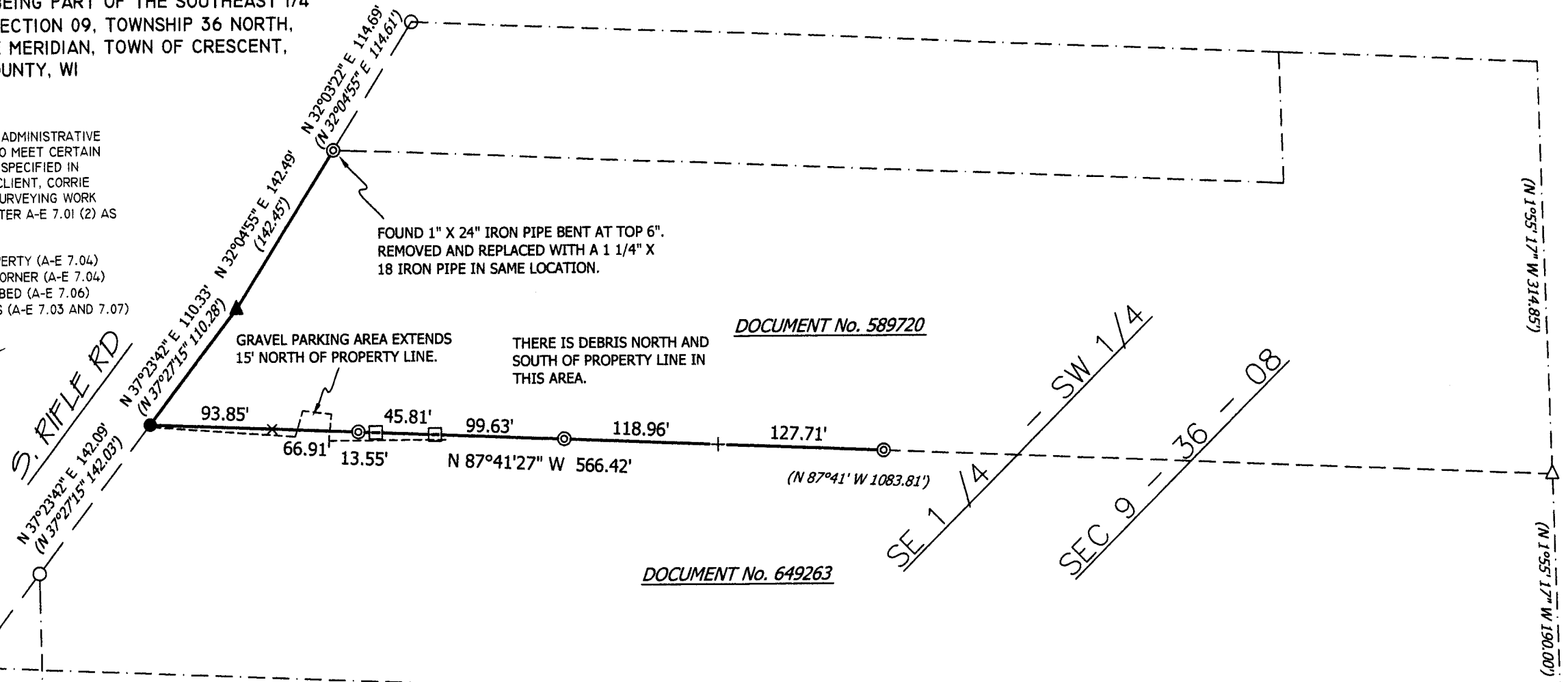
SURVEYOR'S CERTIFICATE AND WAIVER
