



A parcel of land located in The SE 1/4 - SW 1/4, Section 34, T37N, R08E, Town Of Newbold, Oneida County, Wisconsin, described as follows:

Commencing at the south 1/4 corner of said section 34, thence N89°49'28"W, a distance of 1174.54 feet to a point and point of beginning of a line by agreement as shown on Bixby Land Surveying Inc. drawing number 743; thence leaving said line by agreement, N89°49'28"W, a distance of 21.48 feet to a point; thence N00° 19'46"E, a distance of 192.50 feet to an iron pipe at the terminous of said line by agreement; thence along said line by agreement, S28°00'35"E, a distance of 58.13 feet to an iron pipe; thence S00°15'48"E, a distance of 16.33 feet to an iron pipe; thence S07°12'25"W, a distance of 51.03 feet to an iron pipe; thence S00°27'38"W, a distance of 42.54 feet to an iron pipe; thence S00°27'38"W, a distance of 31.75 feet to the point of beginning. Said parcel contains 4,012 square feet or 0.09 acre. Said parcel to be attached to and made a part of those lands lying to the west of the above described parcel and not to be sold as a separate parcel of land.
