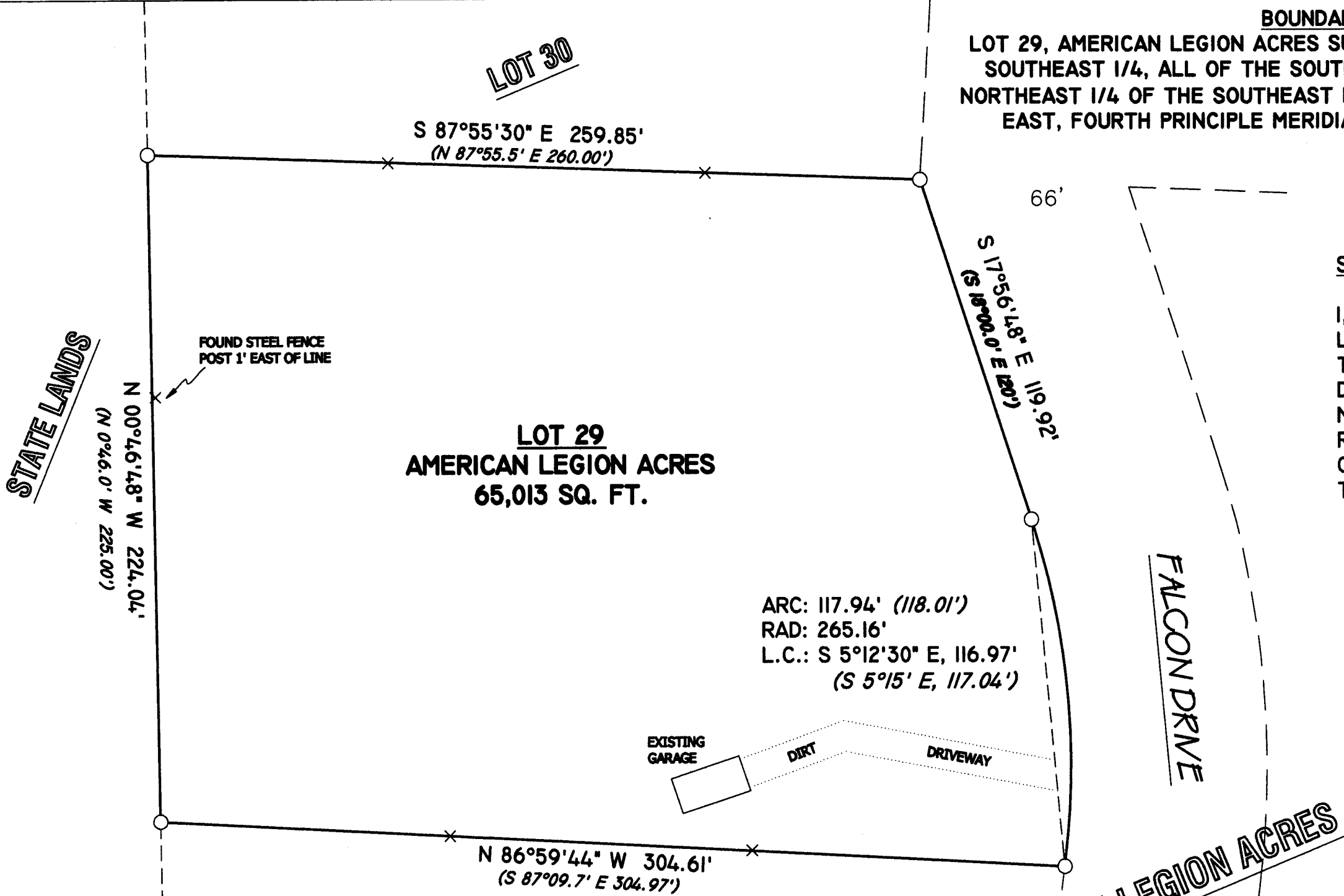


BOUNDARY RETRACEMENT SURVEY

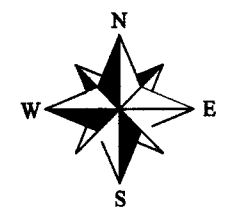
