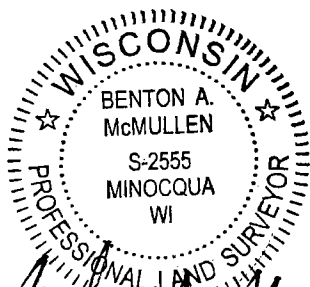
Two Sisters
