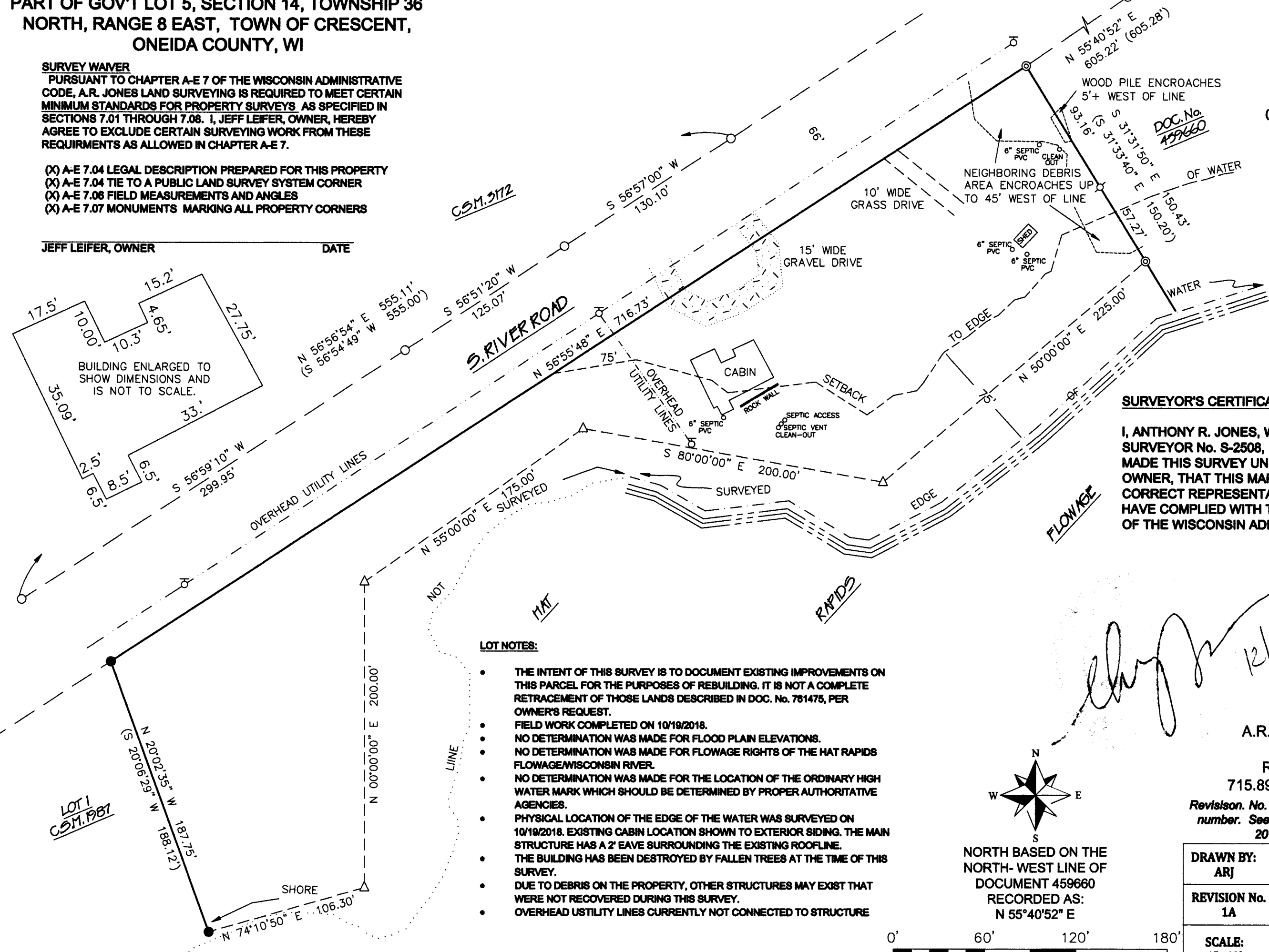
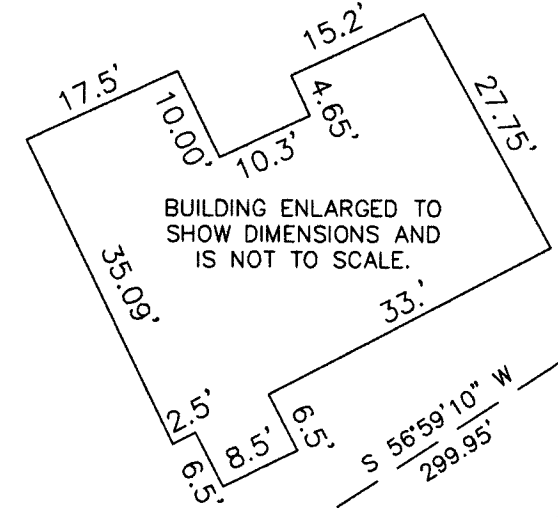
SURVEY WAIVER

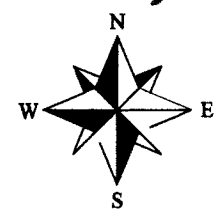
