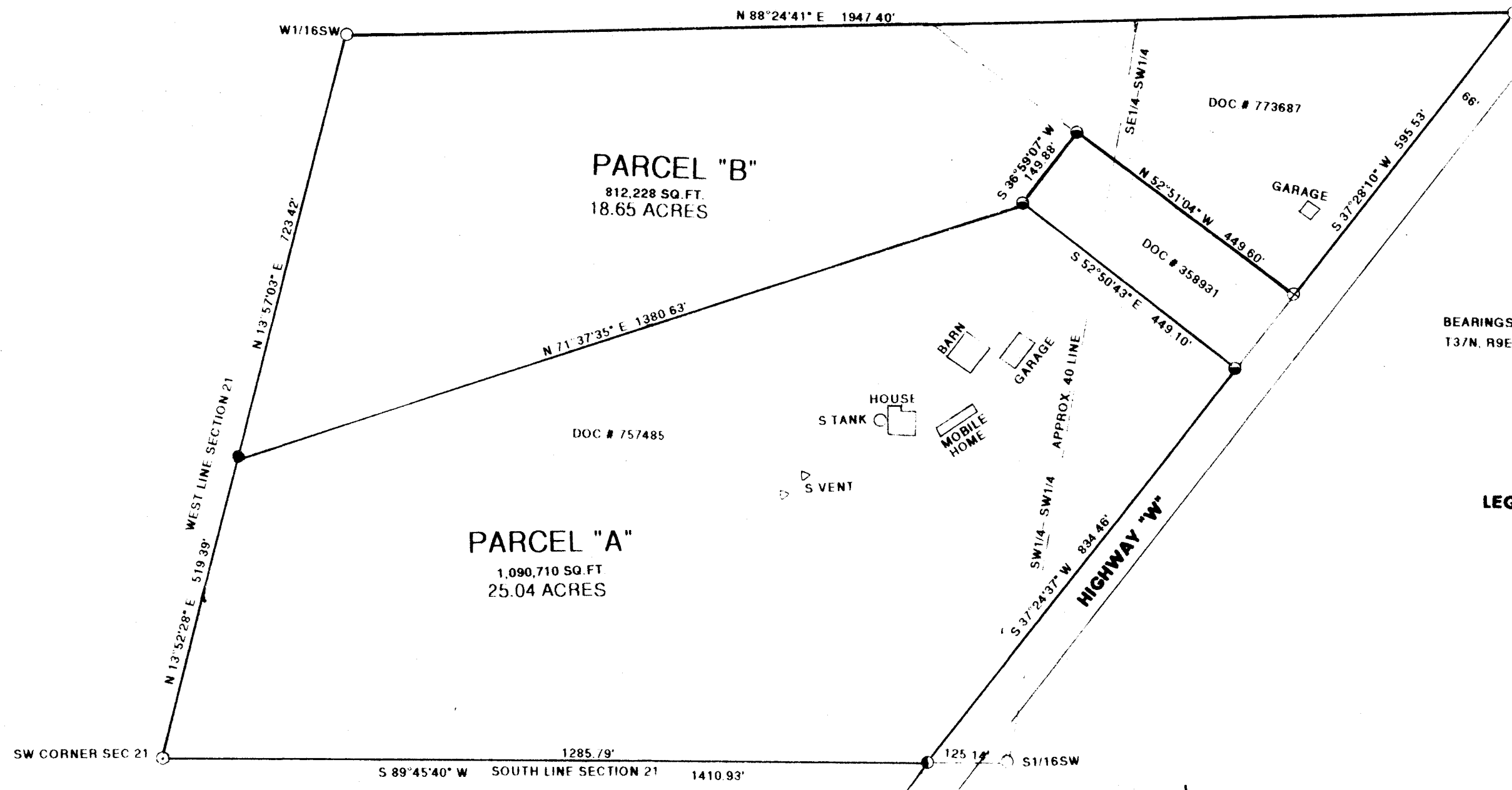
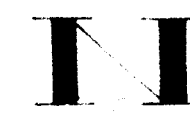

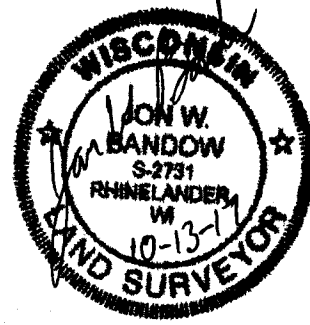

 SECTION 21, T37N, R9E, TOWN OF PINE LAKE, ONEIDA COUNTY, WI.**



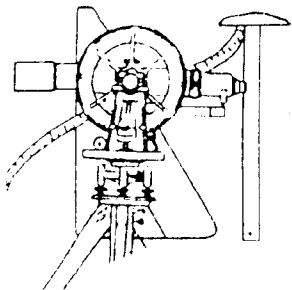

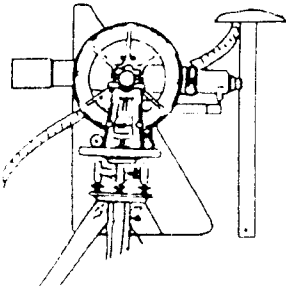

Commencing at an Oneida County Aluminum Monument marking the southwest corner of said section 21 and the point of beginning, thence along the west line of said section 21 N 13°52'28" E a distance of 519.39' to a rebar on the west line of said section 21, thence leaving said west line N 71°37'35" E a distance of 1380.63' to an iron pipe, thence S 52°50'43" E a distance of 449.10' to an iron pipe on the northwesterly right of way line of Highway "W", thence along said right of way line S 37°24'37" W a distance of 834.46' to an iron pipe on the south line of said section 21, thence leaving said right of way line and along said south section line S 89°45'40" W a distance of 1285.79' to the point of beginning.
