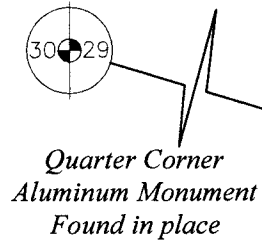

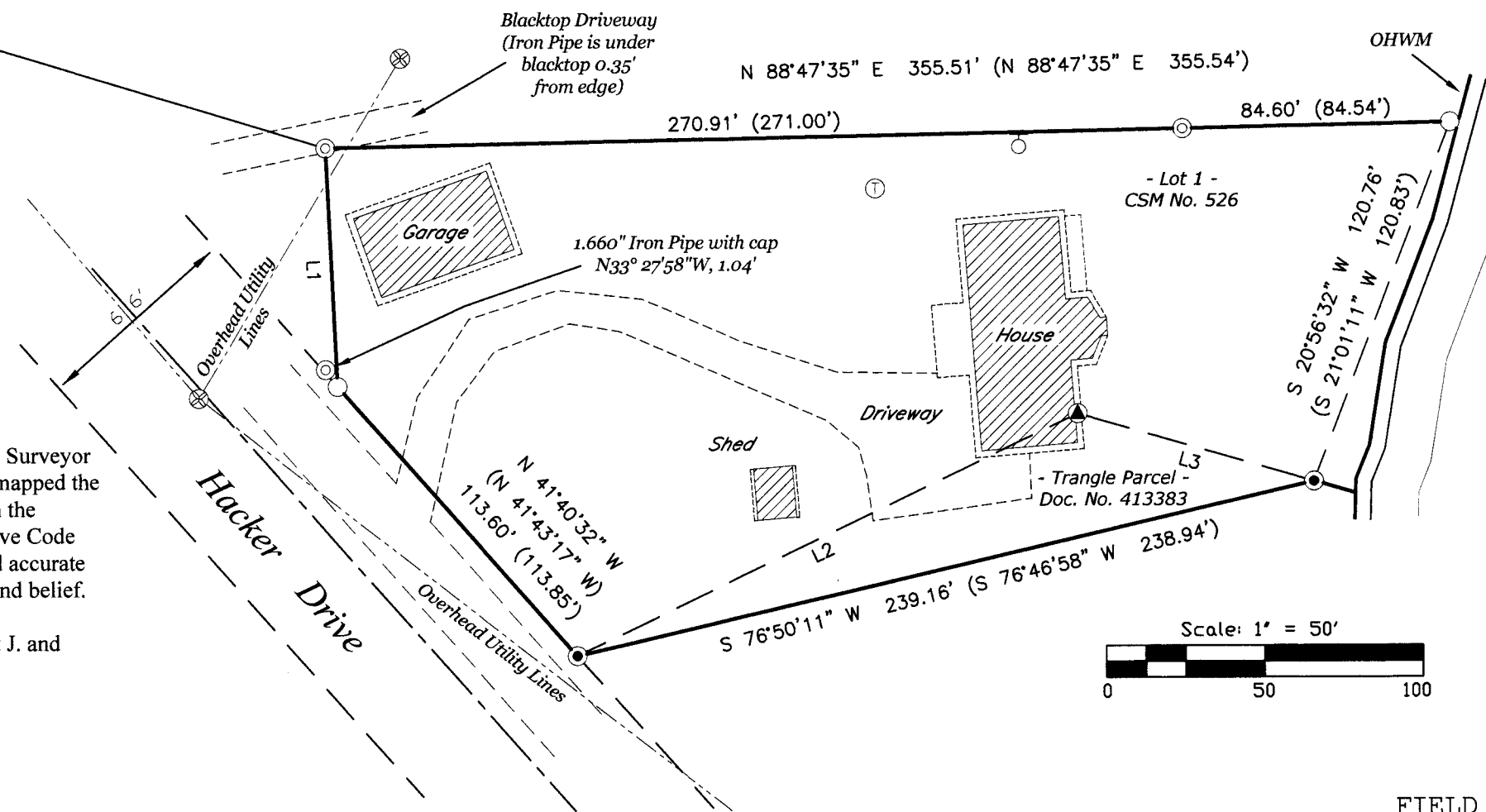
NOTES

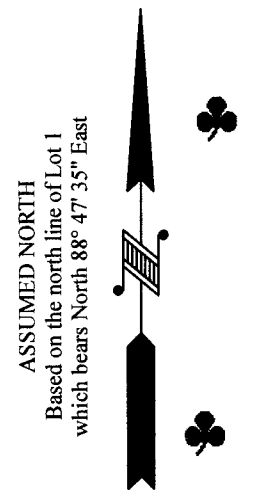
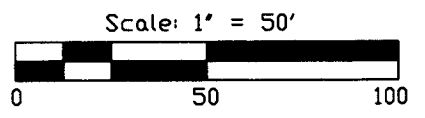

**EXTERIOR DESCRIPTION - TRIANGLE PARCEL**  
Part of Government Lot 4, Section 29, Township 39 North, Range 6 East, Town of Minocqua, Oneida County, Wisconsin as shown on a survey map by McMullen & Associates, Incorporated of Minocqua, Wisconsin dated the 17th day of December, 2019 with a job number of 220005 and previously described in document number 413383 as recorded at the Oneida County Register of Deeds office and more particularly described as follows:

Commencing at the west quarter corner of said section marked by an aluminum monument; thence S 73°15'43" E (Assumed north based on the north line of lot 1 of CSM number 526 which bears N 88°47'35" E) a distance of 1375.80' to a 1.660" iron pipe; thence S 02°56'12" E a distance of 75.01' to a 1.050" iron pipe on the northeastern right of way of Hacker Drive; thence along said right of way S 41°40'32" E a distance of 113.60' to a 1 1/4" iron bar, said point being the POINT OF BEGINNING.

Thence leaving said right of way N 64°21'44" E a distance of 175.48' to a point; thence S 73°57'59" E a distance of 77.70' to a 1 1/4" iron bar near the shore of Blue Lake; thence leaving said shore S 76°50'11" W a distance of 239.16' to the point of beginning.
