A parcel of land in Government Lot 1, Section 6, Township 37 North, Range 7 East, Town of Cassian, Oneida County, Wisconsin, being parcel "-A-", shown on Map No. 20-224, by Wilderness Surveying, Inc., dated January 4, 2021, more particularly described as follows:

Commencing at the meander corner where the east line of Section 6 intersects the northerly shore of Sand Lake, marked by a capped aluminum monument; thence meandering along the lake, S 69'20'11"W for a distance of 101.49 feet to an iron pipe; and S 44'59'07"W for a distance of 99.26 feet to the place of beginning, marked an iron pipe on the southerly line of that parcel of land described in Volume 648 Records, page 518.

Thence continuing along the lake, S 31°06'42"W for a distance of 198.53 feet to an iron pipe on the northeasterly line of that parcel of land described in Document Number 779860; thence N 43°50'26"W for a distance of 229.43 feet along the northeasterly line of that parcel of land described in Document Number 779860, to an iron pipe in the centerline of a private access and utility easement, and being at the southerly most corner of that parcel of land described in Vol. 882 Records, page 740; thence along the centerline of said private access and utility easement and along the southeasterly line of that parcel of land described in Volume 882 Records, page 740, N 44°44'37"E for a distance of 6.11 feet to an iron pipe; and N 43°05'49"E for a distance of 142.36 feet to the westerly most corner of that parcel of land described in Volume 648 Records, page 518; thence S 57°00'56"E for a distance of 190.66 feet along the southerly line of that parcel of land described in Volume 648 Records, page 518, to the place of beginning.

The above described lateral lot lines extend to the northwesterly shore of Sand Lake; and includes all those lands lying between the meander line and the ordinary high water mark.
