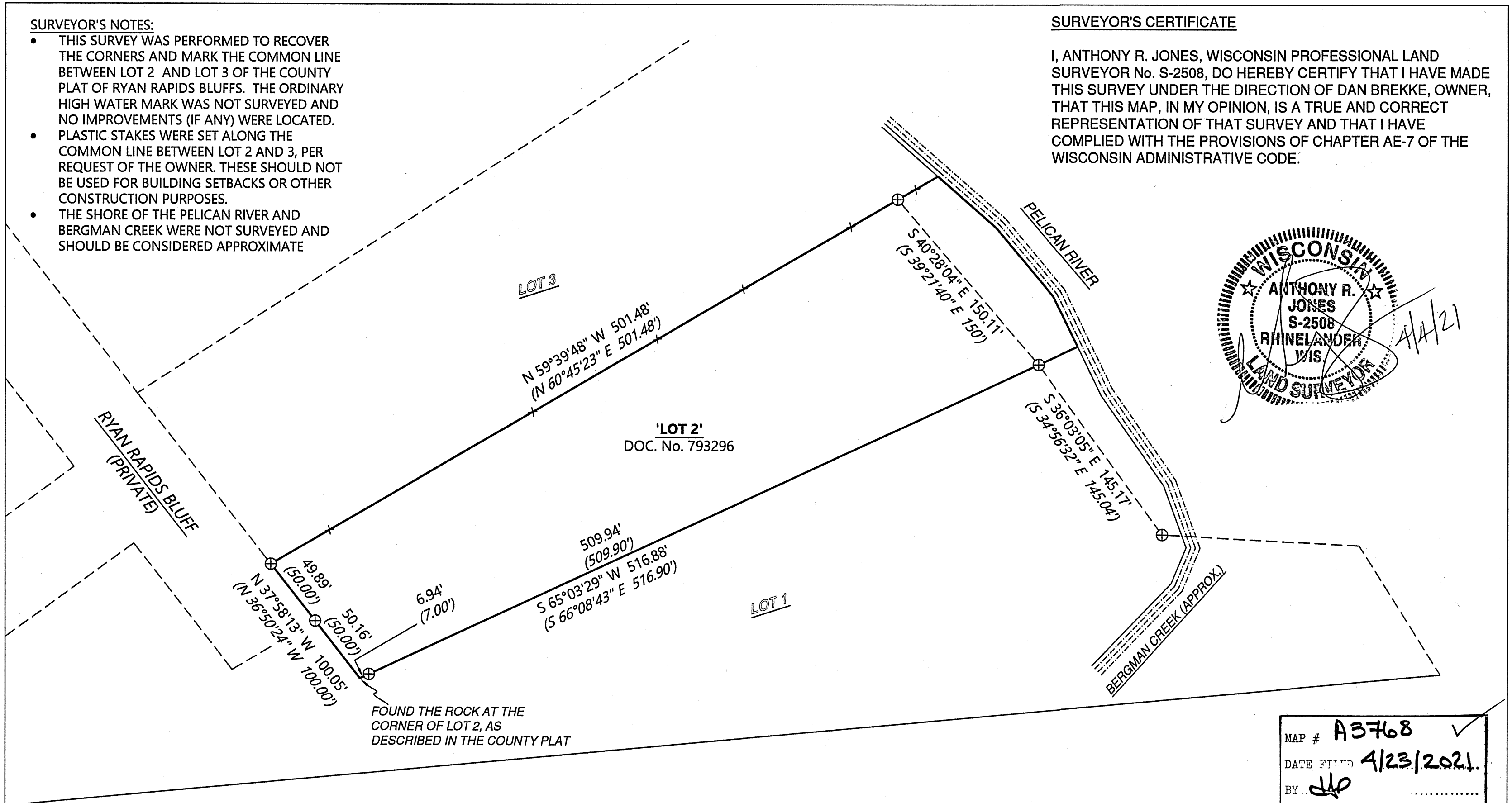
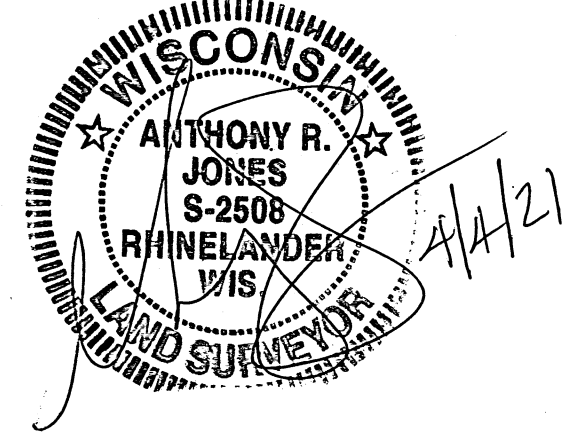


**SURVEYOR'S NOTES:**

- THIS SURVEY WAS PERFORMED TO RECOVER THE CORNERS AND MARK THE COMMON LINE BETWEEN LOT 2 AND LOT 3 OF THE COUNTY PLAT OF RYAN RAPIDS BLUFFS. THE ORDINARY HIGH WATER MARK WAS NOT SURVEYED AND NO IMPROVEMENTS (IF ANY) WERE LOCATED.
- PLASTIC STAKES WERE SET ALONG THE COMMON LINE BETWEEN LOT 2 AND 3, PER REQUEST OF THE OWNER. THESE SHOULD NOT BE USED FOR BUILDING SETBACKS OR OTHER CONSTRUCTION PURPOSES.
- THE SHORE OF THE PELICAN RIVER AND BERGMAN CREEK WERE NOT SURVEYED AND SHOULD BE CONSIDERED APPROXIMATE

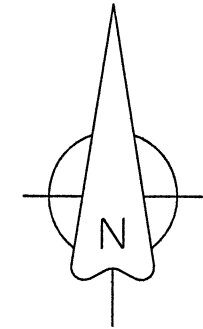
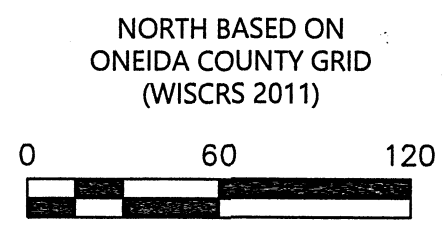
