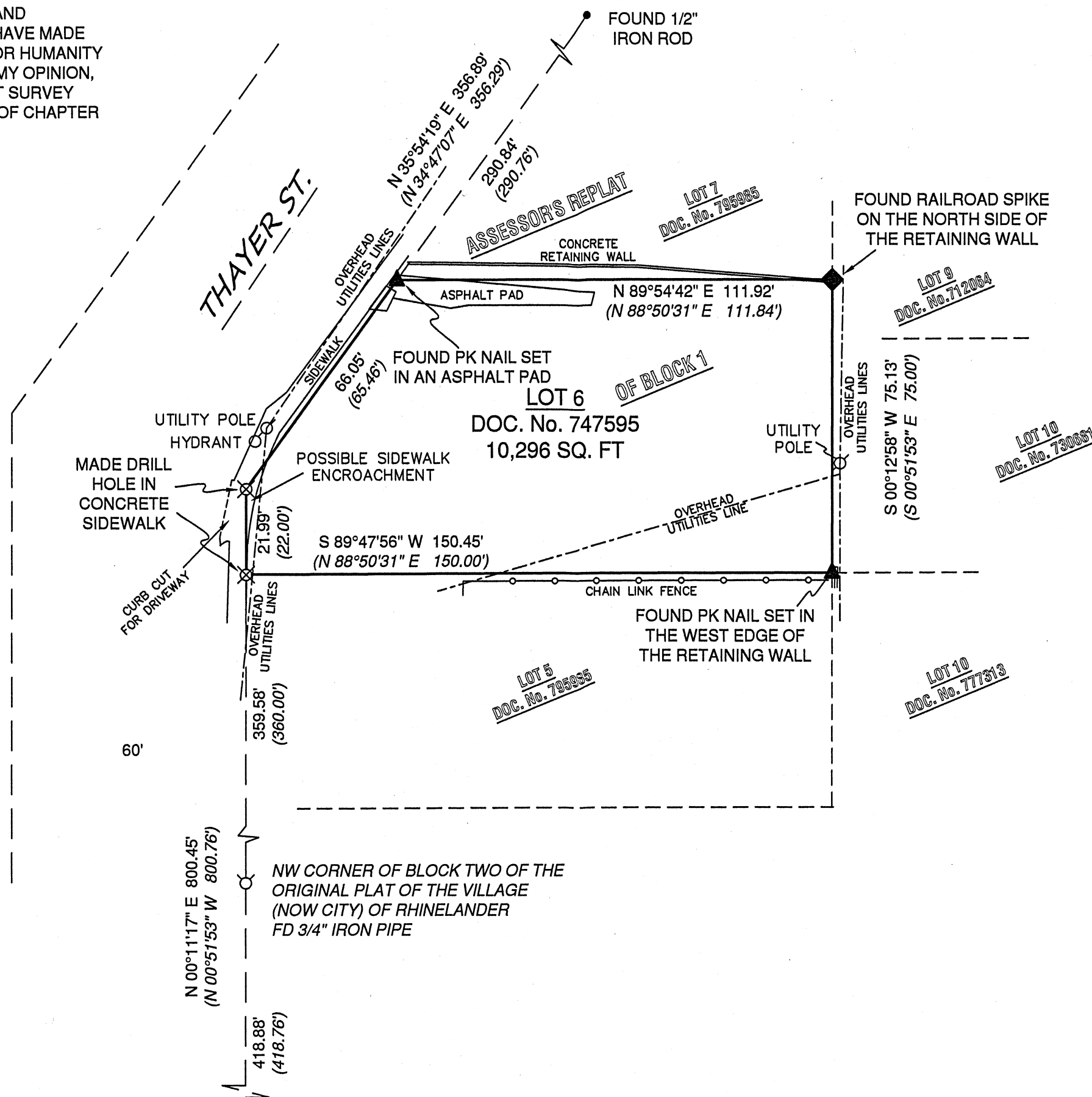
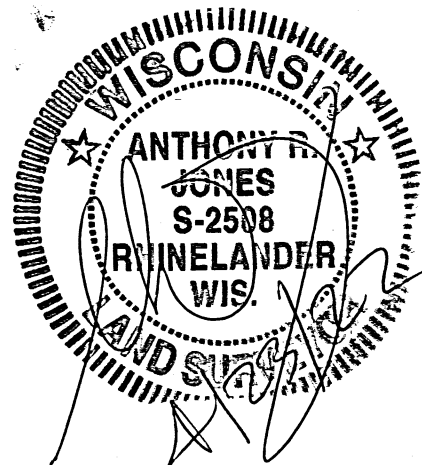


SURVEYOR'S CERTIFICATE

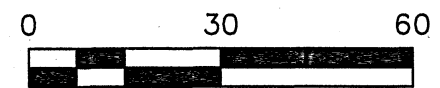
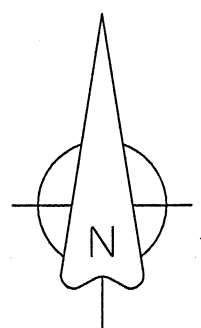
