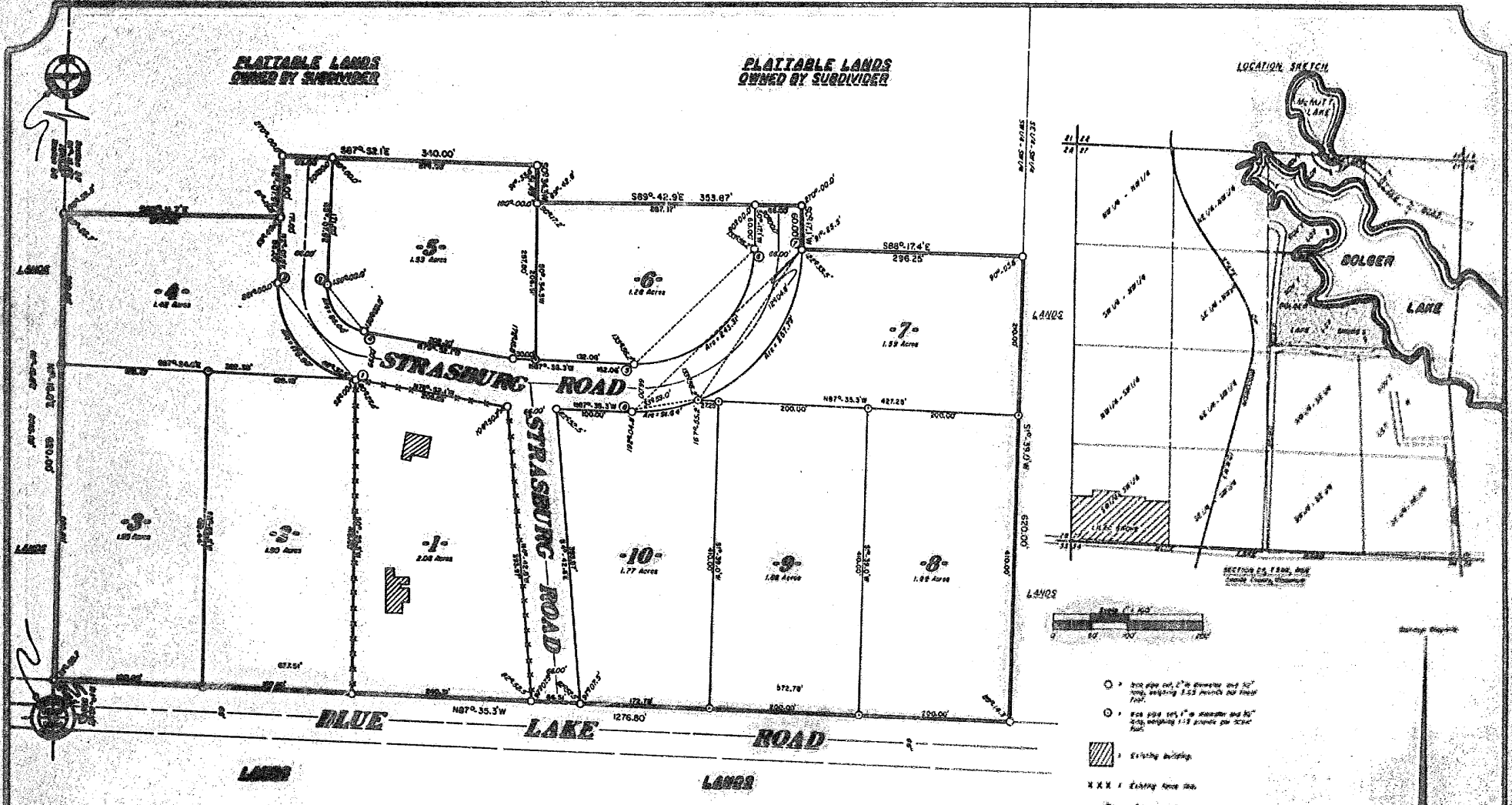

**SURVEYOR'S CERTIFICATE**

I, John H. Fisher, Registered Land Surveyor No. S-836, hereby certify: that in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Minocqua, and under the direction of Willard M. Strasburg, owners of said land, I have surveyed, divided, and mapped LILAC GROVE, that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed:

Being a parcel of land in the SW 1/4 of the SW 1/4, Section 27, T39N, R6E, Minocqua Township, Oneida County, Wisconsin, more particularly described as follows:

Commencing at the Section Corner common to Sections 27, 28, 33 and 34, marked by a 1 1/2" iron pipe; thence N1°-15.0'E, 50.01 feet along the west line of the SW 1/4 of the SW 1/4 to the place of beginning on the northerly right-of-way line of Blue Lake Road, marked by a 2" iron pipe.
