

SURVEYOR'S CERTIFICATE

I, James M. Marquardt, registered land surveyor, No. 11/25, hereby certify: That in full compliance with the provisions of Charter 236 of the Misconsin Statutes, and the subdivision regulations of the Town of Minocqua, and under the direction of Charles A. Clark, owner of said land, I have surveyed, divided, and mapped Clark's Homesites, that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed.

Being a parcel of land located in the SE $1/l_1$ of the NV $1/l_1$, Section $2l_1$, 739%, R65, Minocqua Township, Oneida County, Wisconsin, more particularly described as follows:

Commencing at the one quarter corner common to Sections 23 and 2h, marked by a 6" round concrete monument, witnessed by a 16" Norway pine bearing Sh*2, 38.1 feet; thence N89*21'52"", 1hJh.19 feet along the east - west one quarter line to the one-sighth corner marked by an angle iron, being the southwest corner of the SE 1/h of the NW 1/h; thence Nh*20'13"5, 653.12 along the west line of the SE 1/h of the NW 1/h; to the place of beginning, h.rked by a 3/h" iron rod on the northerly right of way line of Thoroughfare Road.

Thence Nh°20'13"E, 655.5h feet to the one-sixteenth corner marked by a 1-1/2" capped iron pire, witnessed by a 12" Cak bearing 57h'W, hô.6 feet and a 10" Oak bearing 527°W, 52.0 feet being the northwest corner of the SE 1/h of the NN 1/h; thence N80°5'156"E, 1077.93 feet along the north line of the SE 1/h of the NW 1/h; to a 2" iron pipe; thence 51°53'17"W, 826.33 feet to a 2" iron pipe on the northerly right of way line of ThoroughTere Road; thence along said right of way line N82°51'17"W, 505.h2 feet to a 2" iron pipe; N83°11'17"W, 201.6h feet to a 2" iron pipe; N85°16'11"W, 290.13 feet to a 2" iron pipe, and N67°13'59"W, 116.89 feet to the place of teginning.
