


## SURVEYOR'S CERTIFICATE

I, Stuart L. Foltz, Registered Land Surveyor No. S-1170, hereby certify: That in full compliance with the provisions of Chapter 236 of the Misconsin Statutes and the subdivision regulations of the Town of Newbold, and under the direction of Frank Pinc and Mary Pinc, owners of said land, I have surveyed, divided and mapped NORTH NOKOMIS SHORES, that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed:


Being a parcel of land in Gov't. Lot 7, Section 24, T39N, R8E, Oneida County, Wisconsin, more particularly described as follows:

Commencing at the northwest corner of Gov't. Lot 7, a meander corner, marked by a W.C.D. brass-capped iron pipe near the southerly shore of North Nokomis Lake; thence SO\*-14.2'E, (solar bearing) 732.85 feet to the southwest corner of Gov't. Lot 7, a one-eighth corner, marked by an iron pipe; thence S80\*-21.1'E, 1320.24 feet to the southeast corner of Gov't. Lot 7, a one-sixteenth corner, marked by an iron pipe; thence NO\*-O8.0'E, 461.23 feet along the east line of Gov't. Lot 7 to the place of beginning, marked by an iron pipe on the northerly right-of-way line of County Trunk Highway "D".


