

SURVEYOR'S CERTIFICATE

I, JOHN H. FISHER, registered land surveyor, hereby certify:
That in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Newbold, and under the direction of Edwin W. Hunter, Jr., owner of said land, I have surveyed, divided and mapped JACK PINE FOREST; that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed; being a parcel of land in the SW# of the SE#, Section 27, T39N, R8E, Oneida County, Wisconsin, more particularly described as follows:

Commencing at the one-quarter corner common to Sections 27 and 34, marked by a Wisconsin Conservation Department brass capped iron pipe; thence S88°-13'E, 995.00 feet to the place of beginning, marked by an iron pipe.

Thence continuing S88°-13'E, 316.06 feet to the one-eighth corner, marked by an iron pipe; thence N0°-02'W, 1315.44 feet to the one-sixteenth corner, marked by an iron pipe; thence N88°-24'W, 581.33 feet to an iron pipe; thence S88°-24'E, 575°-46'W, 242.40 feet to an iron pipe; thence S88°-24'E, 500.42 feet to an iron pipe; thence S0°-02'E, 1248.40 feet to the place of beginning.

That 0 = iron pipe two inches in diameter and 30 inches long, minimum weight 3.65 pounds per lineal foot. All other lot corners monumented with iron pipe one inch in diameter and $2^{\rm h}$ inches long, minimum weight 1.13 pounds per lineal foot.
