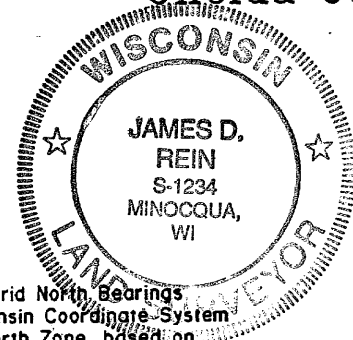

 solar observation

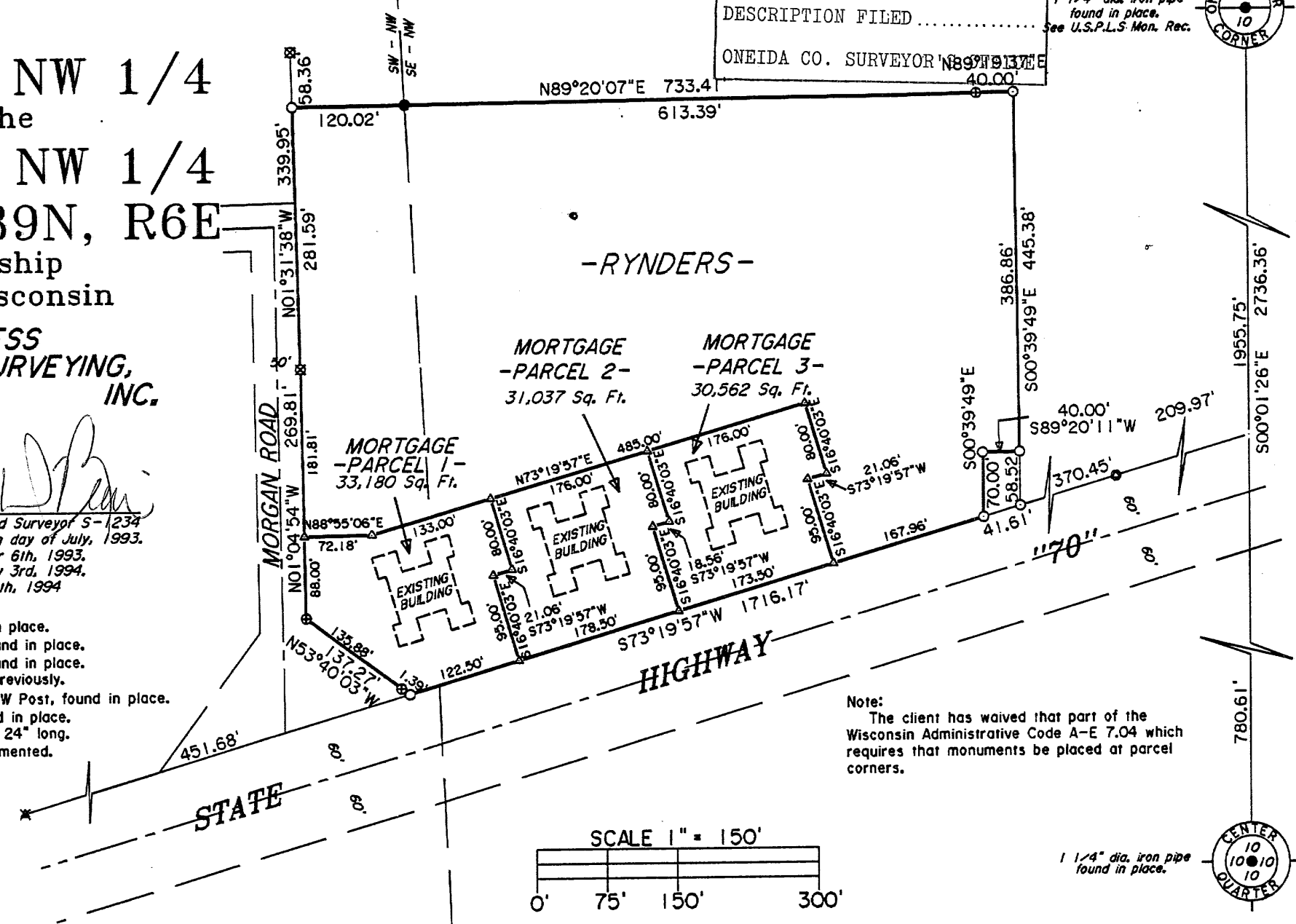
