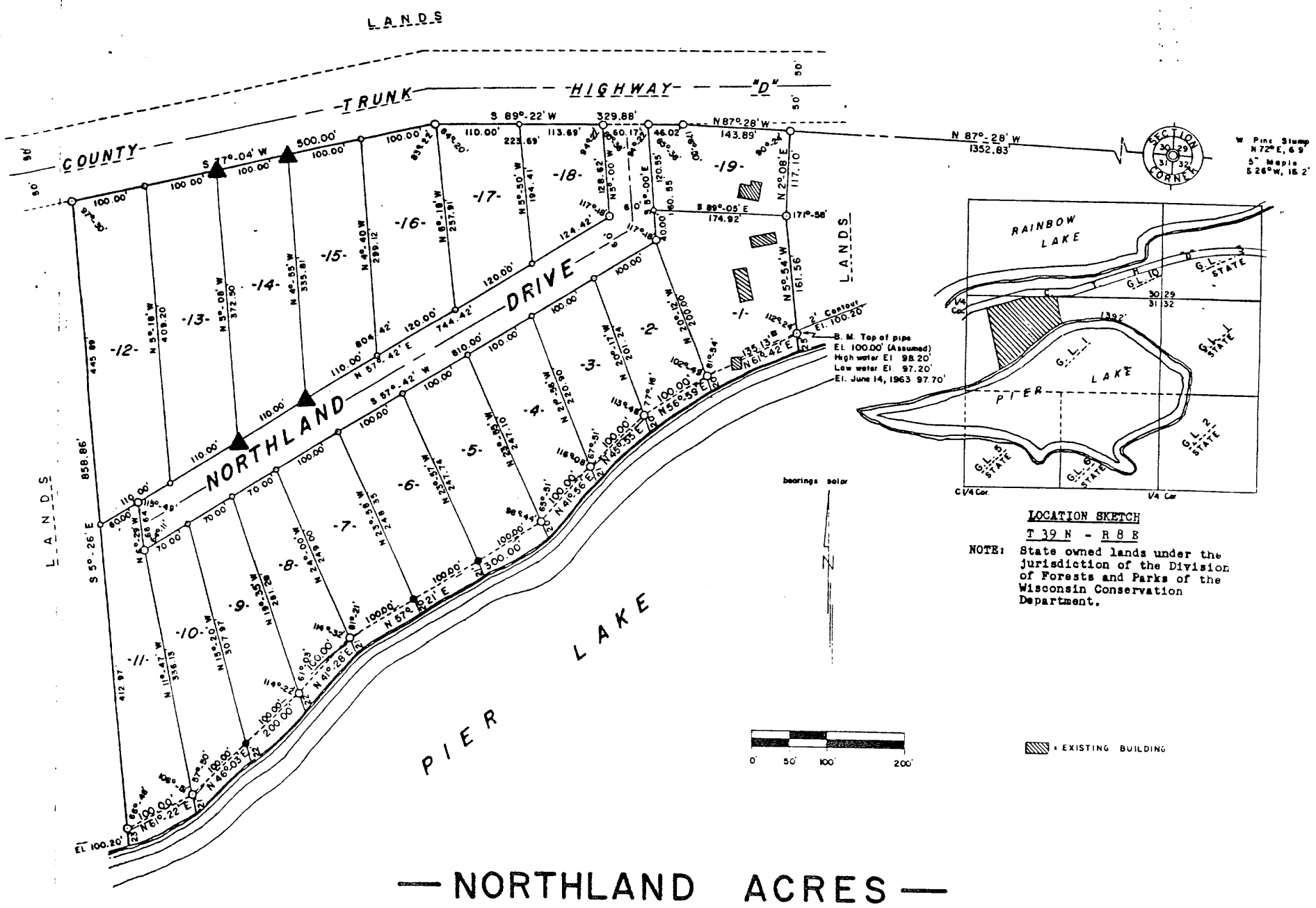

I, JAMES G. GRIFFIN, Registered Land Surveyor, hereby certify:  
 That I have surveyed, divided and mapped NORTHLAND ACRES, located in the Town of Newbold, County of Oneida and State of Wisconsin.  
 That I have made such survey, land-division and plat by the direction of ROSS A. and BLANCHE E. SKINKLE, owners of said land. Being a parcel of land in Gov't. Lot 1, Section 31, T 39 N, R 8 E, Oneida County, Wisconsin, more particularly described as follows:  
 Commencing at the northeast corner of Section 31, marked by an iron pipe, witnessed by a White Pine stump bearing N. 72° E.; 6.9 feet and a 5" Maple bearing S. 26° W. 16.2 feet; thence N. 87° - 28' W.; (Solar bearing) 1352.83 feet along the north line of Section 31 to the place of beginning, marked by an iron pipe.  
 Thence continuing N. 87° - 28' W., 143.89 feet to an iron pipe on the southerly right-of-way of County Trunk Highway "D"; thence S. 89° - 22' W., 329.88 feet along the right-of-way to an iron pipe; thence S. 77° - 04' W., 500.00 feet along the right-of-way to an iron pipe; thence S. 5° - 26' E., 858.86 feet along the right-of-way to an iron pipe near the shore of Pier Lake; thence meandering along the lake N. 61° - 22' E., 100.00 feet; N. 46° - 03' E., 200.00 feet; N. 41° - 28' E., 100.00 feet; N. 57° - 21' E., 300.00 feet; N. 41° - 56' E., 100.00 feet; E. 45° - 55' E., 100.00 feet; N. 56° - 59' E., 100.00 feet; and N. 61° - 42' E., 135.13 feet to an iron pipe; thence N. 5° - 54' W., 161.56 feet to an iron pipe; thence N. 2° - 08' E., 117.10 feet to the place of beginning.  
 Including also all land lying between the meander line and the shore of Pier Lake.  
 That such plat is a correct representation of all the exterior boundaries of the land surveyed and the subdivision thereof made.
