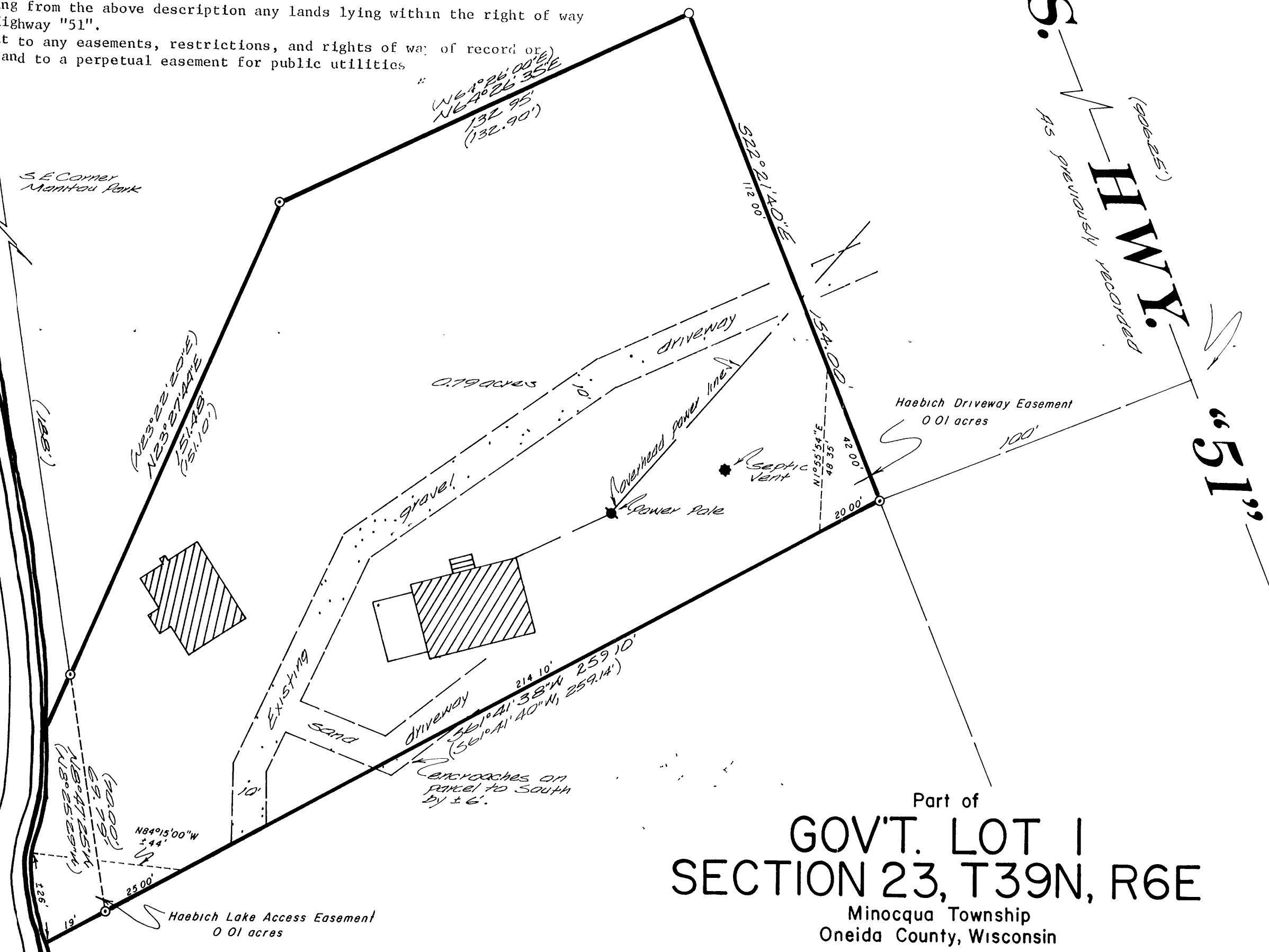

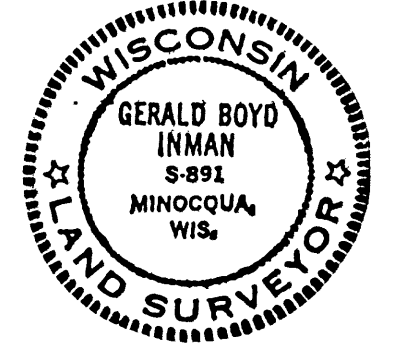
Part of Gov't Lot 1, Section 23, T39N, R6E, Minocqua Township, Oneida County, Wisconsin, more particularly described as follows:
Commencing at the northeast corner of Gov't Lot 1, the 1/4 corner common to Sections 14 and 23; thence west along the north line of said Gov't Lot 1, a distance of 562 feet to the centerline of U.S. Highway "51", thence southeasterly along said centerline 906.25 feet to a point; thence southwesterly at a right angle to said centerline 100 feet to the place of beginning, marked by an iron pipe.
Thence S61°41'40"W, 259.14 feet to an iron pipe on the shore of Lake Minocqua; thence N8°25'29"W, 70.00 feet along the shore of Lake Minocqua to an iron pipe which is 188 feet from the southeast corner of Manitou Park; thence N23°22'20"E, 151.10 feet to an iron pipe, thence N64°26'00"E, 132.90 feet to an iron pipe; thence S22°21'40"E, 154.00 feet to an iron pipe and the place of beginning.
Said parcel contains 0.79 acres.
The above lateral lot lines bearing N23°22'20"E and S61°41'40"W extend to the lake, including all riparian rights thereto.
Excepting from the above description any lands lying within the right of way of U.S. Highway "51".
Subject to any easements, restrictions, and rights of way of record or of use, and to a perpetual easement for public utilities.

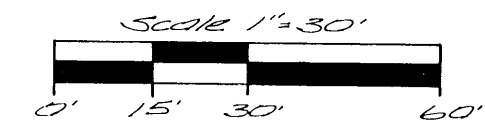
