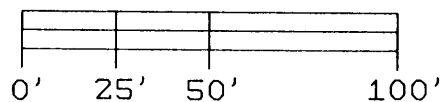

MATZ PARCEL

A parcel of land in Government Lot 4, Section 11 Township 39 North, Range 5 East, Minocqua Township, Oneida County, Wisconsin, being the "MATZ" parcel shown on Map No 91-24 by Wilderness Surveying, Inc dated April 18th, 1991, more particularly described as follows

Commencing at Meander Corner where the line common to Section 10 and Section 11 intersects the southerly shore of Shishebogama Lake, marked by a capped aluminum monument, thence South 78 degrees 09 minutes 13 seconds East for a distance of 298.37 feet to the place of beginning, marked by an iron pipe near the southerly shore of Shishebogama Lake and being on the easterly line of that parcel of land described in Volume 198 of Deeds, on page 181

Thence meandering along the lake North 28 degrees 08 minutes 42 seconds East for a distance of 250.12 feet to an iron pipe, thence South 63 degrees 32 minutes 08 seconds East for a distance of 226.27 feet to an iron pipe, thence South 06 degrees 14 minutes 36 seconds East for a distance of 241.83 feet to an iron pipe, thence North 70 degrees 48 minutes 52 seconds West for a distance of 367.24 feet to the place of beginning

The southwesterly line of said parcel of land extends along the easterly line of that parcel of land described in Volume 198 of Deeds, on page 181, North 00 degrees 19 minutes 30 seconds East to the lake and the northeasterly line extends North 63 degrees 32 minutes 08 seconds West to the lake, including all riparian rights thereto,

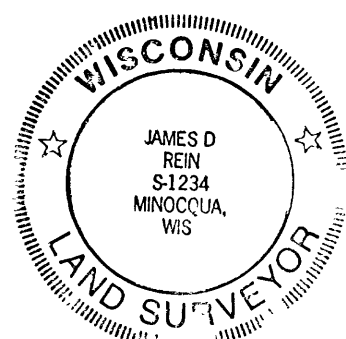
