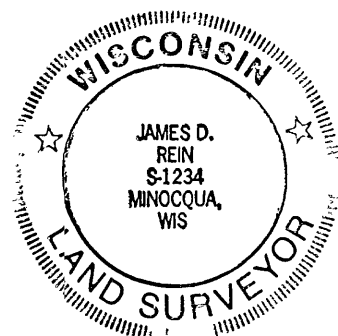

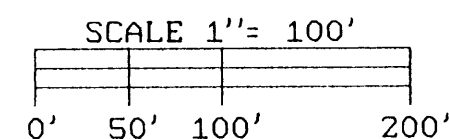

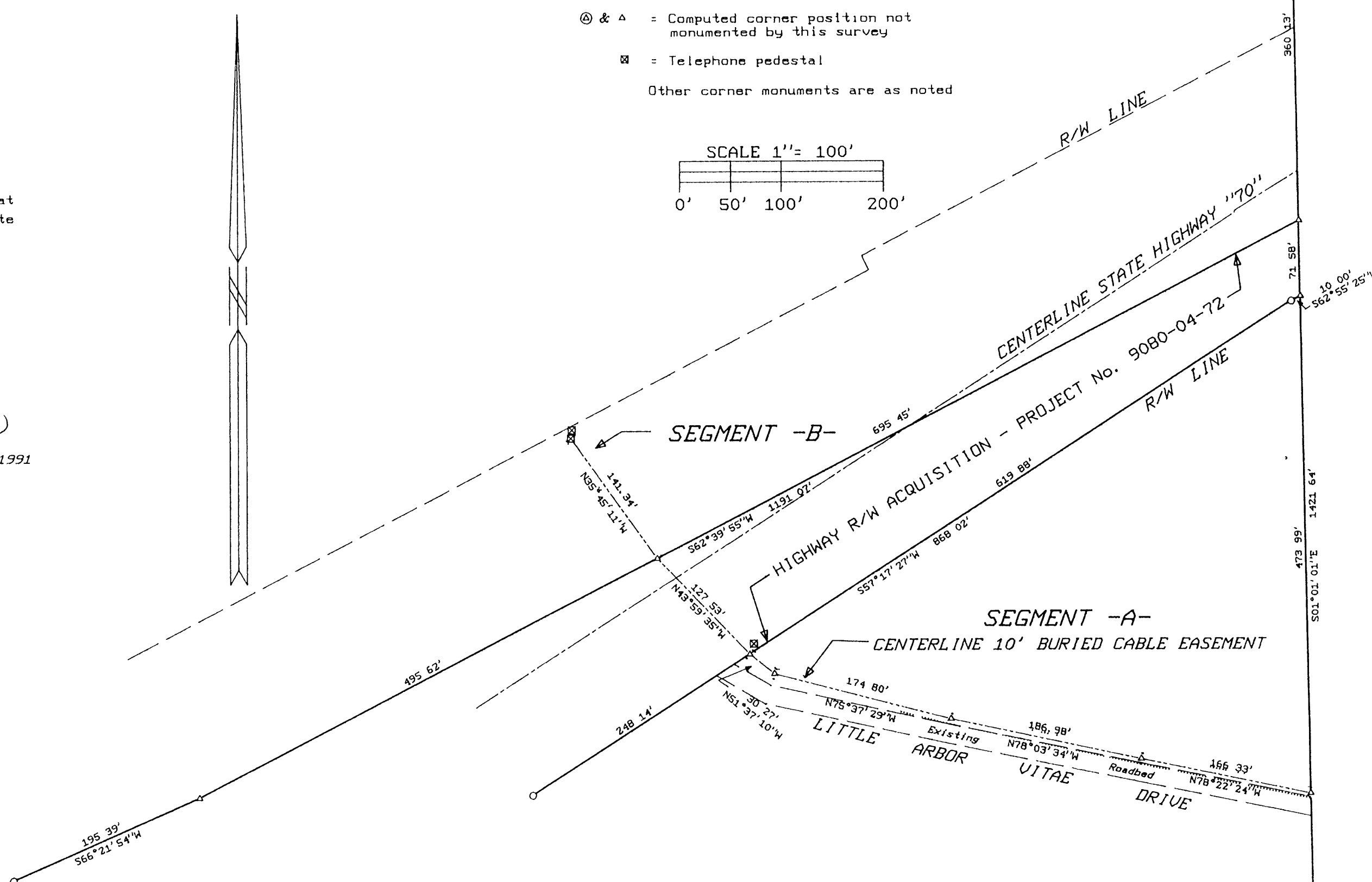
Bearings Grid North,

EASEMENT FOR BURIED CABLE - SEGMENT "A"

A strip of land ten feet in width for purpose of an easement for buried cable in Government Lot 3, Section 29, Township 40 North, Range 7 East, Arbor Vitae Township, Vilas County, Wisconsin, being shown on Map No. 91-114 by Wilderness Surveying, Inc., dated December 19th, 1991, the centerline of which is more particularly described as follows.

Commencing at the east quarter corner of Section 29, marked by a W.C.D. brass capped iron pipe, thence South 01 degrees 01 minutes 01 seconds East for a distance of 905.70 feet along the east line of Section 29 to the place of beginning of said centerline

Thence along said centerline North 78 degrees 22 minutes 24 seconds West for a distance of 166.33 feet, thence continuing along said centerline North 78 degrees 03 minutes 34 seconds West for a distance of 186.98 feet; thence continuing along said centerline North 75 degrees 37 minutes 29 seconds West for a distance of 174.80 feet, thence continuing along said centerline North 51 degrees 37 minutes 10 seconds West for a distance of 30.27 feet to the southerly right of way line of State Highway "70" and there terminating

EASEMENT FOR BURIED CABLE - SEGMENT "B"

A strip of land ten feet in width for purpose of an easement for buried cable in Government Lot 3, Section 29, Township 40 North, Range 7 East, Arbor Vitae Township, Vilas County, Wisconsin, being shown on Map No. 91-114 by Wilderness Surveying, Inc., dated December 19th, 1991, the centerline of which is more particularly described as follows

Commencing at the east quarter corner of Section 29, marked by a W.C.D. brass capped iron pipe, thence South 01 degrees 01 minutes 01 seconds East for a distance of 360.13 feet along the east line of Section 29, thence South 62 degrees 39 minutes 55 seconds West for a distance of 695.45 feet to the place of beginning of said centerline

Thence along said centerline North 35 degrees 45 minutes 11 seconds West for a distance of 141.34 feet and there terminating
