## MONTY PARCEL

A parcel of land in Government Lot 4, Section 14, Township 38 North, Range 7 East, Lake Tomahawk Township, Onelda County, Wisconsin, being the "MONTY" parcel shown on Map No. 92-83 by Wilderness Surveying, Inc., dated July 29th, 1992, more particularly described as follows


Commencing at the the Quarter Corner common to Sections 13 and 14, marked by a capped aluminum monument, thence North 89 degrees 07 minutes 42 seconds West for a distance of 3062 09 feet along the quarter line to the Meander Corner, marked by an iron pipe near the easterly shore of Horsehead Lake, thence meandering along the shore of Horsehead Lake, South 09 degrees 35 minutes 04 seconds East for a distance of 203 49 feet to the northwest corner of Lot 1 of Oneida County Certified Survey Map No 386, thence continuing along the lake South 16 degrees 46 minutes 21 seconds East for a distance of 314 50 feet to the place of beginning at the southwest corner of Lot 3 of Oneida County Certified Survey map No 386, marked by an Iron pipe

Thence continuing along the shore of Horsehead Lake South 15 degrees 21 minutes 07 seconds East for a distance of 104 03 feet to an Iron pipe, thence South 89 degrees 07 minutes 48 seconds East for a distance of 1526 72 feet to an Iron rod on the westerly right of way line of State Highway "47", thence North 00 degrees 05 minutes 54 seconds East for a distance of 100 14 feet along the westerly right of way line of State Highway "47" to the southeast corner of Lot 4 of Onelda County Certified Survey Map No 386, marked by an Iron rod, thence North 89 degrees 08 minutes 21 seconds West for a distance of 1554 43 feet to the place of beginning

The above lateral lot lines extend to the shore of Horsehead lake, including all riparian rights thereto
