TAFT PARCEL

A parcel in the Southwest Quarter of the Southwest Quarter, Section 7, Township 38 North, Range 7 East, Lake Tomahawk Township, Oneida County, Wisconsin, being the "TAFT" parcel shown on Map No. 92-105 by Wilderness Surveying, Inc., dated October 9th, 1992, more particularly described as follows:

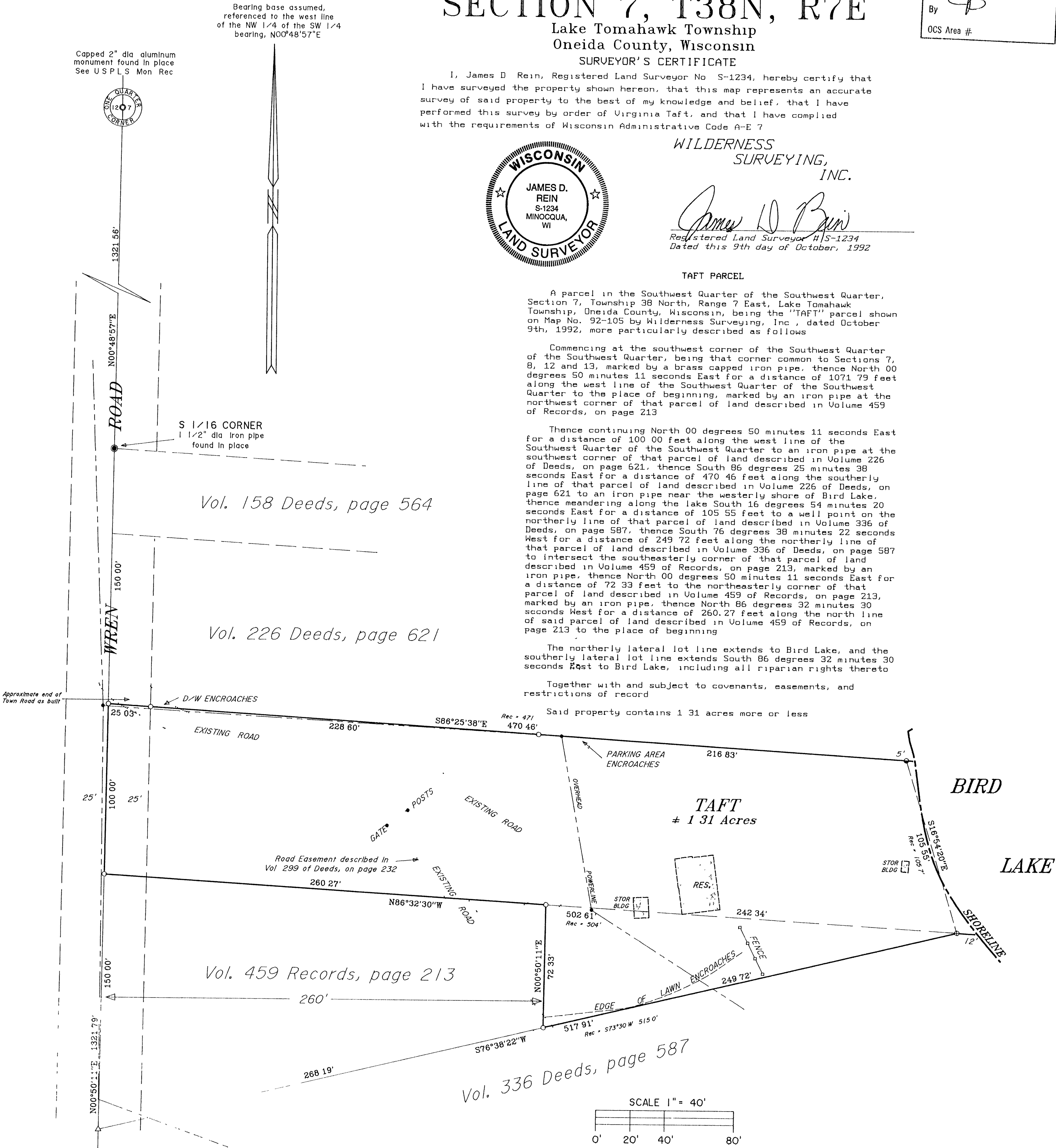
Commencing at the southwest corner of the Southwest Quarter of the Southwest Quarter, being that corner common to Sections 7, 8, 12 and 13, marked by a brass capped iron pipe, thence North 00 degrees 50 minutes 11 seconds East for a distance of 1071.79 feet along the west line of the Southwest Quarter of the Southwest Quarter to the place of beginning, marked by an iron pipe at the northwest corner of that parcel of land described in Volume 459 of Records, on page 213.

Thence continuing North 00 degrees 50 minutes 11 seconds East for a distance of 100.00 feet along the west line of the Southwest Quarter of the Southwest Quarter to an iron pipe at the southwest corner of that parcel of land described in Volume 226 of Deeds, on page 621, thence South 86 degrees 25 minutes 38 seconds East for a distance of 470.46 feet along the southerly line of that parcel of land described in Volume 226 of Deeds, on page 621 to an iron pipe near the westerly shore of Bird Lake, thence meandering along the lake South 16 degrees 54 minutes 20 seconds East for a distance of 105.55 feet to a well point on the northerly line of that parcel of land described in Volume 336 of Deeds, on page 587, thence South 76 degrees 38 minutes 22 seconds West for a distance of 249.72 feet along the northerly line of that parcel of land described in Volume 336 of Deeds, on page 587 to intersect the southeasterly corner of that parcel of land described in Volume 459 of Records, on page 213, marked by an iron pipe, thence North 00 degrees 50 minutes 11 seconds East for a distance of 72.33 feet to the northeasterly corner of that parcel of land described in Volume 459 of Records, on page 213, marked by an iron pipe, thence North 86 degrees 32 minutes 30 seconds West for a distance of 260.27 feet along the north line of said parcel of land described in Volume 459 of Records, on page 213 to the place of beginning.

The northerly lateral lot line extends to Bird Lake, and the southerly lateral lot line extends South 86 degrees 32 minutes 30 seconds East to Bird Lake, including all riparian rights thereto.

Together with and subject to covenants, easements, and restrictions of record.

Said property contains 1.31 acres more or less.
