A parcel of land in Government Lot 1, Section 32, Township 39 North, Range 6 East, Minocqua Township, Oneida County, Wisconsin, previously described in Volume 234 of Deeds on page 196, being the "PAULSEN" parcel shown on Map No 93-26 by Wilderness Surveying Inc., dated June 24th, 1993, more particularly described as follows:

Commencing at the Meander Corner where the line common to Sections 29 and 32 intersects the westerly shore of Blue Lake, marked by a capped aluminum monument, thence meandering along the lake South 14 degrees 09 minutes 47 seconds West for a distance of 96 51 feet, South 19 degrees 49 minutes 16 seconds East for a distance of 119 37 feet and South 86 degrees 56 minutes 20 seconds East for a distance of 128 32 feet to the place of beginning, marked by an iron pipe on the westerly line of that parcel of land described in Volume 234 of Deeds, on page 196

Thence continuing along the lake South 65 degrees 06 minutes 52 seconds East for a distance of 263 45 feet and South 36 degrees 11 minutes 32 seconds East for a distance of 212 23 feet to an iron pipe on the northerly line of that parcel of land described in Volume 280 Deeds, on page 414, thence South 61 degrees 59 minutes 36 seconds West for a distance of 134 75 feet to the northwesterly corner of said parcel of land described in Volume 280 of Deeds, on page 414, marked by an iron pipe, thence South 06 degrees 16 minutes 21 seconds East for a distance of 272 82 feet along the westerly line of said parcel of land described in Volume 280 of Deeds, on page 414 to an iron pipe on the northerly right of way line of Blue Lake Road, thence along said northerly right of way line of Blue Lake Road, along a curve to the right, having a radius of 577 14 feet and an arc length of 230 74 feet, being subtended by a chord of North 66 degrees 56 minutes 09 seconds West for a distance of 229 21 feet to an iron pipe, thence North 55 degrees 28 minutes 57 seconds West for a distance of 198 13 feet along said right of way line to an iron pipe on the westerly line of that parcel of land described in Volume 234 of Deeds, on page 196, thence North 13 degrees 25 minutes 51 seconds East for a distance of 426 19 feet to the place of beginning

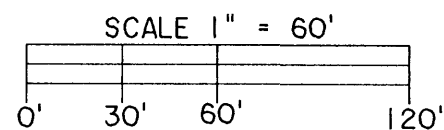
