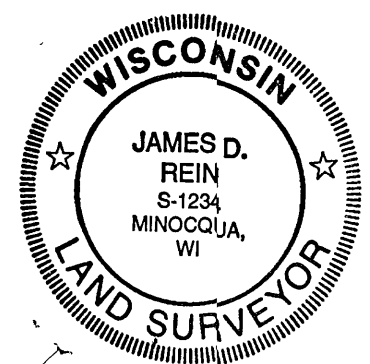

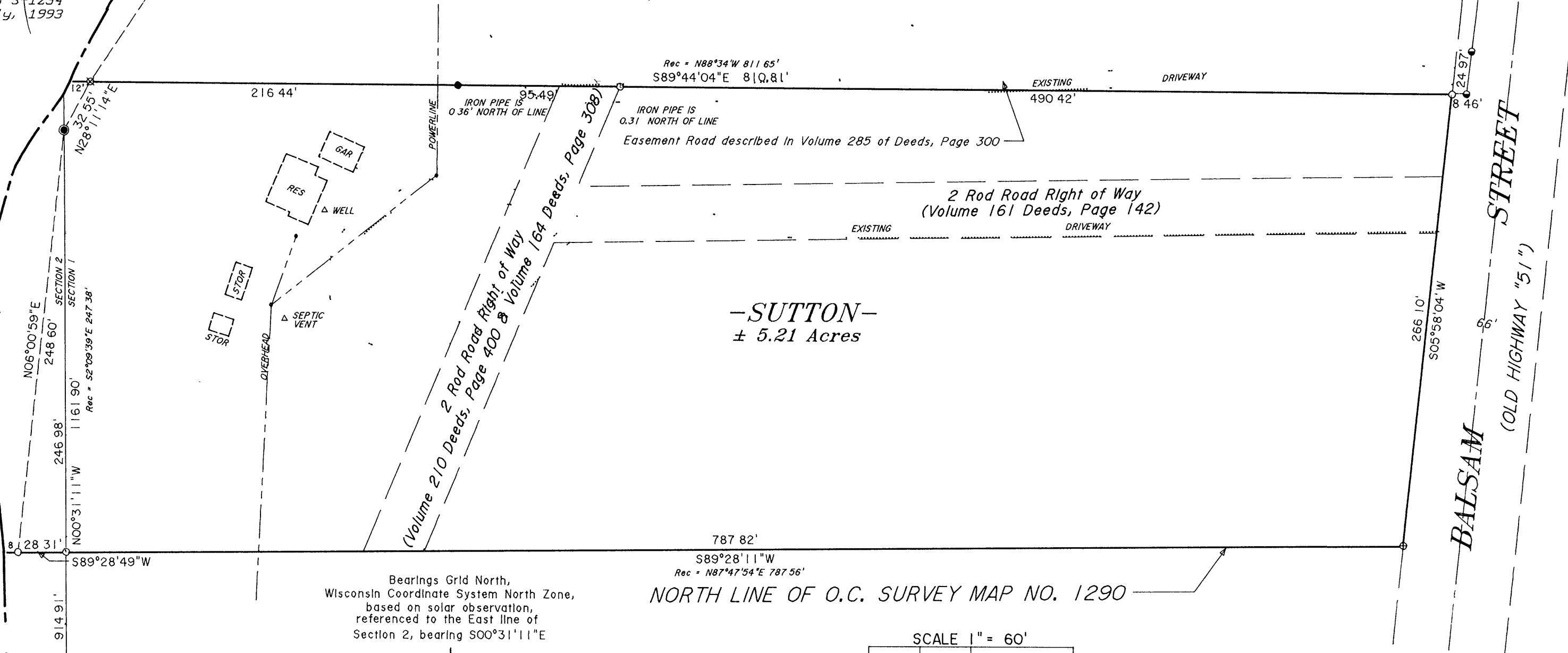

A parcel of land in Government Lot 1, Section 1, and part of Lot G in the plat of the Village of Woodruff, located in Section 2, Township 39 North, Range 6 East, Woodruff Township, Oneida County, Wisconsin, being the "SUTTON" parcel shown on Map No. 93-49 by Wilderness Surveying, Inc., dated July 12th, 1993, more particularly described as follows:

Beginning at the Meander Corner where the line common to Sections 1 and 2 intersects the southeasterly shore of Snake Lake, marked by a capped aluminum monument, thence meandering along the lake North 28 degrees 11 minutes 14 seconds East for a distance of 32.55 feet to an iron pipe on the south line of that parcel of land described in Volume 285 of Deeds, on page 300, thence South 89 degrees 44 minutes 04 seconds East for a distance of 802.35 feet along the south line of that parcel of land described in Volume 285 of Deeds, on page 300 to an iron pipe on the westerly right of way line of Balsam Street, thence South 05 degrees 58 minutes 04 seconds West for a distance of 266.10 feet along the westerly right of way line of Balsam Street to an iron rod on the northerly line of that parcel of land shown on Oneida County Survey Map No. 1290, thence South 89 degrees 28 minutes 11 seconds West for a distance of 787.82 feet along the south line of said parcel of land shown on Oneida County Survey Map No. 1290 to an iron pipe on the line common to Sections 1 and 2, thence South 89 degrees 28 minutes 49 seconds West for a distance of 28.31 feet to an iron pipe near the easterly shore of Snake Lake, thence meandering along the lake North 06 degrees 00 minutes 59 seconds East for a distance of 248.60 feet to the place of beginning.

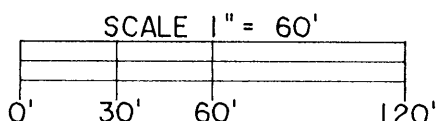
The above lateral lot lines extend to the shore of Snake Lake, including all riparian rights thereto.
