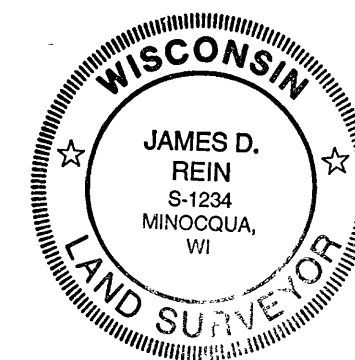

BALL PARCEL

A parcel of land in the Southwest Quarter of the Northwest Quarter, Section 8, Township 39 North, Range 6 East, Minocqua Township, Oneida County, Wisconsin, being the "BALL" parcel shown on Map No. 93-35 by Wilderness Surveying Inc., dated July 28th, 1993, more particularly described as follows

Commencing at the corner common to Sections 5, 6, 7 and 8, marked by a brass capped concrete monument, thence South 01 degrees 59 minutes 53 seconds East for a distance of 1319.71 feet to the North Sixteenth Corner, marked by an iron pipe, thence North 89 degrees 42 minutes 00 seconds East for a distance of 1316.69 feet to the Northwest Sixteenth Corner, marked by an iron spindle in the pavement of Curtis Lake Lane, thence South 10 degrees 59 minutes 20 seconds West for a distance of 42.79 feet the place of beginning, marked by an iron pipe at the northwest corner of Lot 1 shown on Oneida County Certified Survey Map No. 1102 and also being located on the southerly right of way line of Curtis Lake Lane

Thence South 01 degrees 21 minutes 31 seconds East for a distance of 305.74 feet along the west line of said Lot 1 shown on Oneida County Certified Survey Map No. 1102 to an iron pipe near the northerly shore of Curtis Lake, thence meandering along the lake South 89 degrees 35 minutes 36 seconds West for a distance of 98.71 feet to an angle iron on the east line of that parcel of land described in Volume 160 of Deeds, on page 329, thence North 01 degrees 36 minutes 04 seconds West for a distance of 301.85 feet along the east line of that parcel of land described in Volume 160 of Deeds, on page 329 to an iron pipe on the southerly right of way line of Curtis Lake Lane, thence North 87 degrees 21 minutes 03 seconds East for a distance of 100.00 feet along said right of way line to the place of beginning

The above lateral lot lines extend to the shore of Curtis Lake, including all riparian rights thereto

Together with and subject to covenants, easements, and restrictions of record
