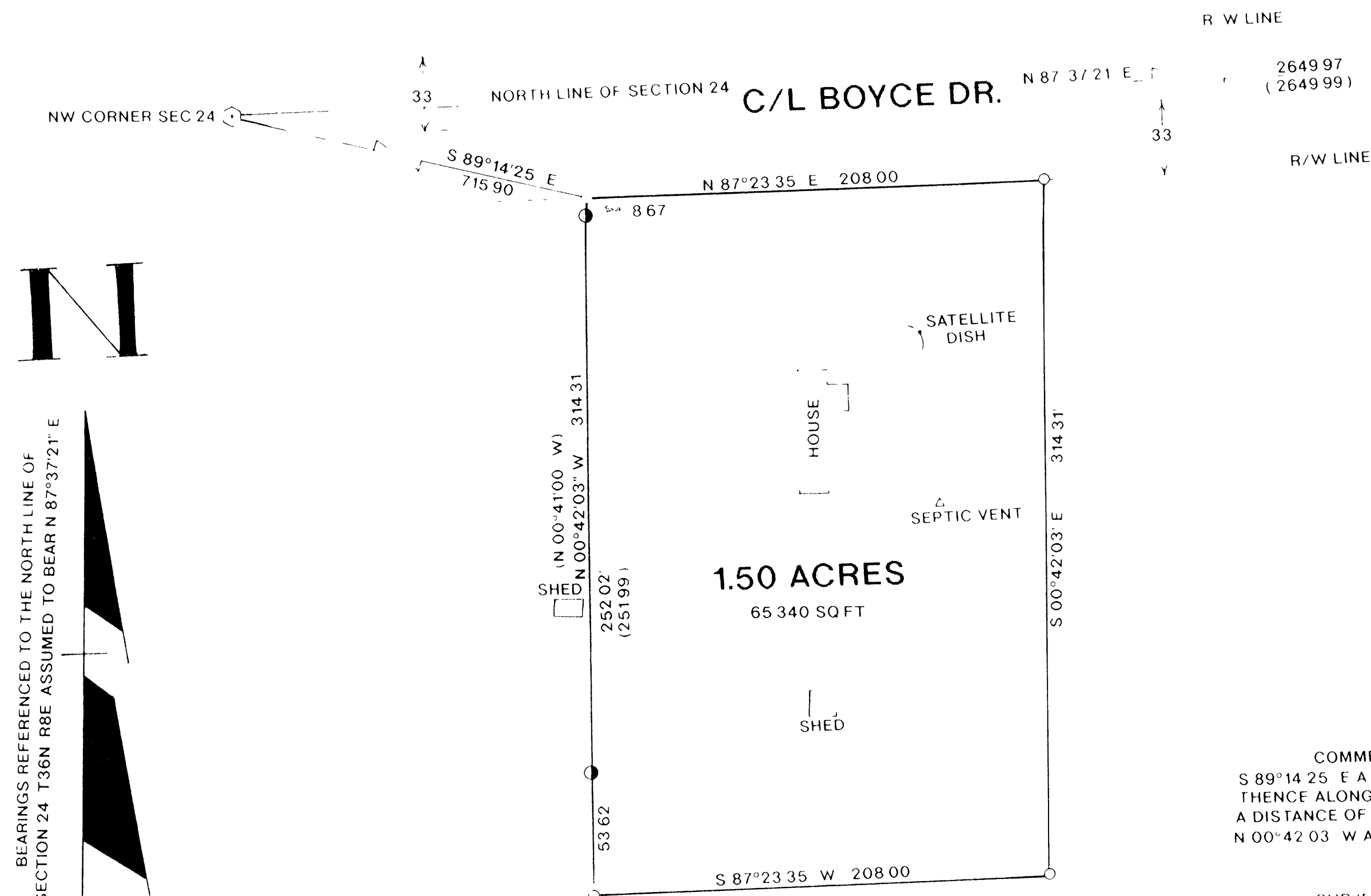

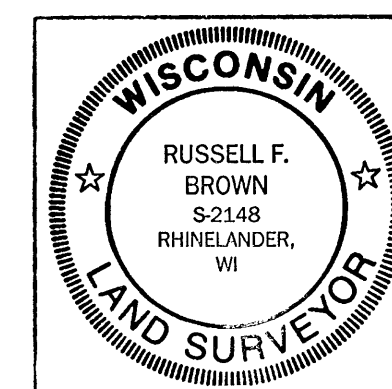
LEGAL DESCRIPTION

COMMENCING AT AN ONEIDA COUNTY MONUMENT MARKING THE NW CORNER OF SECTION 24, T36N R8E, THENCE S 89°14'25" E A DISTANCE OF 715.90' TO AN IRON ROD ON THE SOUTHERLY R/W OF BOYCE DRIVE AND POINT OF BEGINNING, THENCE ALONG SAID R/W N 87°23'35" E A DISTANCE OF 208.00' TO AN IRON ROD, THENCE LEAVING SAID R/W S 00°42'03" E A DISTANCE OF 314.31' TO AN IRON ROD, THENCE S 87°23'35" W A DISTANCE OF 208.00' TO AN IRON ROD, THENCE N 00°42'03" W A DISTANCE OF 314.31' TO AN IRON ROD AND POINT OF BEGINNING.
