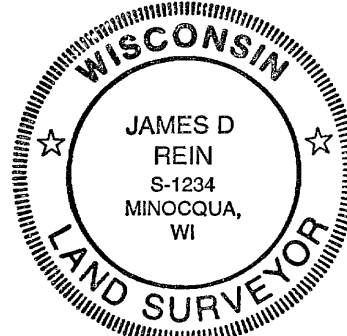

PARCEL -A-

A parcel of land in Government Lot 2, Section 15, Township 38 North, Range 7 East, Lake Tomahawk Township, Oneida County, Wisconsin, being parcel "A-" shown on map No. 95-79 by Wilderness Surveying, Inc., dated August 1st, 1995, more particularly described as follows:

Commencing at the Meander Corner, where the line common to Sections 15 and 22 intersects the easterly shore of South Two Lakes, marked by a capped aluminum monument; thence North 02 degrees 33 minutes 16 seconds East for a distance of 1095.06 feet to an iron pipe near the northerly shore of South Two Lakes; thence meandering along the lake North 49 degrees 58 minutes 44 seconds West for a distance of 55.00 feet; North 12 degrees 07 minutes 12 seconds East for a distance of 45.00 feet to an iron pipe; North 36 degrees 35 minutes 02 seconds West for a distance of 37.00 feet, North 86 degrees 23 minutes 54 seconds West for a distance of 25.30 feet to an iron pipe and North 41 degrees 31 minutes 26 seconds West for a distance of 34.75 feet to an iron pipe on the westerly line of that parcel of land described in Volume 477 of Records, on page 229; thence North 04 degrees 27 minutes 09 seconds East for a distance of 408.81 feet along the westerly line of that parcel of land described in Volume 477 of Records, on page 229 to the place of beginning, marked by an iron pipe.

Thence continuing along the westerly line of said parcel of land described in Volume 477 of Records, on page 229 North 04 degrees 27 minutes 09 seconds East for a distance of 300.00 feet to an iron pipe on the southerly right of way line of Two Lakes Road; thence South 62 degrees 45 minutes 25 seconds East for a distance of 84.91 feet along said southerly right of way line to an iron pipe, thence South 01 degrees 56 minutes 18 seconds East for a distance of 256.73 feet to an iron pipe, thence South 88 degrees 03 minutes 42 seconds West for a distance of 107.53 feet to an iron pipe.

Commencing at the Meander Corner, where the line common to Sections 15 and 22 intersects the easterly shore of South Two Lakes, marked by a capped aluminum monument; thence North 02 degrees 33 minutes 16 seconds East for a distance of 1095.06 feet to an iron pipe near the northerly shore of South Two Lakes; thence meandering along the lake North 49 degrees 58 minutes 44 seconds West for a distance of 55.00 feet and North 12 degrees 07 minutes 12 seconds East for a distance of 45.00 feet to the place of beginning, marked by an iron pipe on the easterly line of that parcel of land described in Volume 392 of Records, on page 527.

Thence continuing along the lake North 36 degrees 35 minutes 02 seconds West for a distance of 37.00 feet; North 86 degrees 23 minutes 54 seconds West for a distance of 25.30 feet to an iron pipe and North 41 degrees 31 minutes 26 seconds West for a distance of 34.75 feet to an iron pipe on the westerly line of that parcel of land described in Volume 477 of Records, on page 229; thence North 04 degrees 27 minutes 09 seconds East for a distance of 408.81 feet along the westerly line of said parcel of land described in Volume 477 of Records, on page 229 to an iron pipe; thence North 88 degrees 03 minutes 42 seconds East for a distance of 107.53 feet to an iron pipe on the westerly line of that parcel of land described in Volume 496 of Records, on page 805; thence North 01 degrees 56 minutes 18 seconds West for a distance of 256.73 feet along the westerly line of said parcel of land described in Volume 496 of Records, on page 805 to an iron pipe on the southerly right of way line of Two Lakes Road; thence South 63 degrees 11 minutes 27 seconds East for a distance of 57.42 feet along said southerly right of way line to an iron pipe at the northeasterly corner of that parcel of land described in Volume 496 of Records, on page 805; thence South 00 degrees 54 minutes 05 seconds East for a distance of 579.48 feet to an iron pipe at the southeasterly corner of that parcel of land described in Volume 496 of Records, on page 805; thence North 87 degrees 04 minutes 14 seconds West for a distance of 40.00 feet along the southerly line of that parcel of land described in Volume 496 of Records, on page 805 to an iron pipe at an intersection with the easterly line of that parcel of land described in Volume 392 of Records, on page 527; thence South 33 degrees 28 minutes 55 seconds West for a distance of 146.10 feet along the easterly line of said parcel of land described in Volume 392 of Records, on page 527 to the place of beginning.

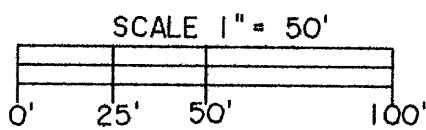
The above lateral lot lines extend to the shore of South Two Lakes, including all riparian rights thereto.
