
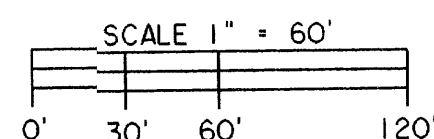

Commencing at the southwest corner of said Southwest Quarter of the Southwest Quarter, being the corner common to Sections 26, 27, 34 and 35, marked by a railroad spike in the pavement of Blue Lake Road, thence North 88 degrees 18 minutes 16 seconds East for a distance of 776.86 feet along the line common to Section 26 and Section 27 to the place of beginning, marked by an iron pipe

Thence North 53 degrees 28 minutes 24 seconds West for a distance of 228 78 feet to an iron pipe on the southeasterly right of way line of U S Highway "51", thence North 33 degrees 50 minutes 30 seconds East for a distance of 405 96 feet along the southeasterly right of way line of U S Highway "51" to an iron pipe on the southwesterly line of Lot 1 of Oneida County Certified Survey Map No 531, thence South 60 degrees 47 minutes 08 seconds East for a distance of 506 11 feet along the southwesterly line of said Lot 1 of Oneida County Certified Survey Map No 531 to an iron pipe, thence South 02 degrees 46 minutes 47 seconds East for a distance of 211 95 feet along the westerly line of said Lot 1 of Oneida County Certified Survey Map No 531 to an iron pipe on the line common to Section 26 and 35, thence South 88 degrees 18 minutes 16 seconds West for a distance of 494 45 feet along the line common to Section 26 and Section 35 to the place of beginning
