Commencing at the northeast corner of the Northeast Quarter of the Northwest Quarter, being the Quarter Corner common to Sections 10 and 15, marked by an Iron pipe, thence North 88 degrees 43 minutes OI seconds West for a distance of 1075 81 feet along the north line of the Northeast Quarter of the Northwest Quarter to an Iron pipe on the easterly right of way line of Squirrel Lake Road, thence along the easterly right of way line of Squirrel Lake Road, along a curve to the left, having a radius of 1175 27 feet and an arc length of 35 20 feet, being subtended by a chord of South 26 degrees 57 minutes 50 seconds West for a distance of 35 20 feet to an Iron pipe, thence South 26 degrees O6 minutes 21 seconds West for a distance of 311.41 feet along the easterly right of way line of Squirrel Lake Road to an Iron pipe, thence along the easterly right of way line of Squirrel Lake Road, along a curve to the right, having a radius of 110540 feet and an arc length of 83 02 feet, being subtended by a chord of South 28 degrees 15 minutes 27 seconds West for a distance of 83 00 feet to the place of beginning, marked by an Iron pipe
