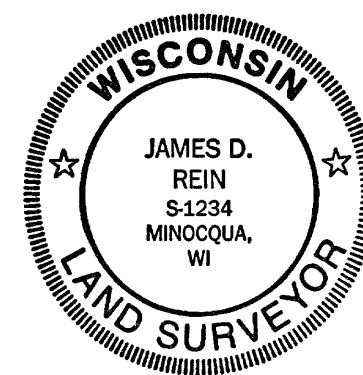

PARCEL -1- (Job No. 97-81)

A parcel of land in Government Lot 3, Section 1, Township 38 North, Range 6 East, Hazelhurst Township, Oneida County, Wisconsin, being parcel "-1-" shown on Map No. 97-81 by Wilderness Surveying, Inc., dated July 9th, 1998, more particularly described as follows

Commencing at the quarter corner common to Section 2 and Section 1, marked by an iron pipe, thence North 84 degrees 42 minutes 42 seconds East for a distance of 2667.69 feet to the Meander Corner at the intersection of the east line of Government Lot 3 with the southerly shore of Tomahawk Lake, marked by an iron pipe, thence meandering along the lake North 72 degrees 18 minutes 45 seconds West for a distance of 118.40 feet to an iron rod, North 64 degrees 49 minutes 23 seconds West for a distance of 99.80 feet to an iron pipe; North 57 degrees 19 minutes 44 seconds West for a distance of 96.02 feet to an iron pipe, and North 54 degrees 45 minutes 51 seconds West for a distance of 110.45 feet to the place of beginning, marked by an iron pipe

Thence continuing along the lake North 54 degrees 45 minutes 51 seconds West for a distance of 24.55 feet to an iron pipe, thence South 00 degrees 11 minutes 43 seconds East for a distance of 457.63 feet to an iron pipe, thence South 64 degrees 46 minutes 15 seconds East for a distance of 22.14 feet to an iron pipe, thence North 00 degrees 11 minutes 43 seconds West for a distance of 452.91 feet to the place of beginning

The above lateral lot lines extend to Tomahawk Lake, and include all lands lying between the meander line and the ordinary high water mark

Together with and subject to covenants, easements, and restrictions of record

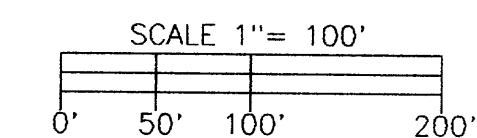
Said property contains 9,400 square feet more or less
