

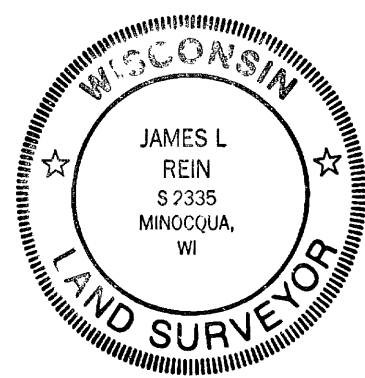

A parcel of land in part of the Northwest Quarter of the Northeast Quarter, Section 15, Township 37 North, Range 5 East, Little Rice Township, Oneida County, Wisconsin, being Parcel "-A-" shown on Map No 99-58 by Wilderness Surveying, Inc., dated April 29th, 1999, more particularly described as follows

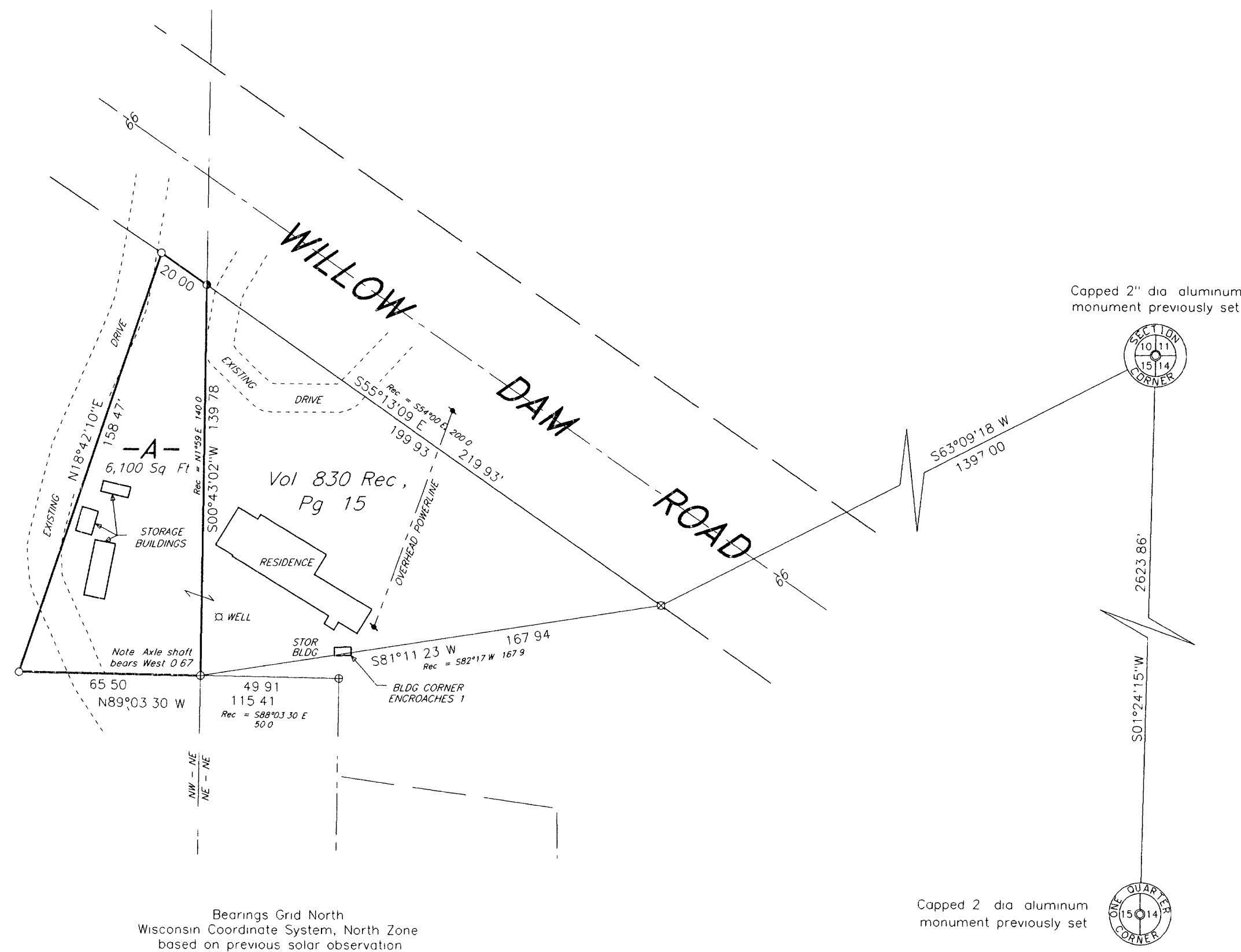
Commencing at the northeast corner of Section 15, marked by an aluminum monument, thence South 63 degrees 09 minutes 18 seconds West for a distance of 1397.00 feet to the intersection of the southerly line of that parcel of land described in Volume 830 of Records, on Page 15, and the southerly right of way line of Willow Dam Road, marked by an iron pipe, thence South 81 degrees 11 minutes 23 seconds West for a distance of 167.94 feet along the southerly line of that parcel of land described in Volume 830 of Records, on Page 15 to the place of beginning, marked by an iron pipe

Thence North 89 degrees 03 minutes 30 seconds West for a distance of 65.50 feet to an iron pipe, thence North 18 degrees 42 minutes 10 seconds East for a distance of 158.47 feet to an iron pipe on the southerly right of way line of Willow Dam Road, thence South 55 degrees 13 minutes 09 seconds East for a distance of 20.00 feet to an iron pipe at the intersection of said southerly right of way line of Willow Dam Road and the westerly line of that parcel of land described in Volume 830 of Records, on Page 15, thence South 00 degrees 43 minutes 02 seconds West for a distance of 139.78 feet along the westerly line of that parcel of land described in Volume 830 of Records, on Page 15, to the place of beginning

Together with and subject to covenants, easements, and restrictions of record

Said property contains 6,100 square feet
